The Departmental Promotion Committee(lower) to prepare select list (for the year 2005) of employees promoted to the cadre of Additional District Officer / Price Supervisory Officer/Senior Research Assistant was held for the last time 31/03/2005. Thereafter due to certain WP(C) filed in the Honourable High Court Challenging the seniority of certain employees in the L.D.Cadre, and subsequent promotions, select list for the posts of Taluk Statistical Officer, Additional District Officer, District Officer could not be prepared. As a result only provisional promotions in the Taluk Statistical Officer, Additional District Officer were granted. Now these WP(C) were settled and seniority lists upto the cadre of Research Assistants/ Statistical Inspectors/E.O(P&M) have been published.

For regularising the provisional promotions given after 2005 to the cadres of Taluk statistical Officer and Additional District Officer and for the preparation of Select list of employees from the year 2006 onwards, the Departmental Promotion Committee (Lower) has been convened on 27/07/2010. The select list has been notified in the Kerala Gazette, vide reference 3rd cited. On the basis of this the provisional promotions ordered to the employees in the cadre of Additional District Officer is regularised with effect from the date noted against their name in the following table


