**ORDER**

Departmental disciplinary action has been taken against Sri.M.Muralidharan (Now Senior Joint Director, Department of Economics and Statistics) based on the Vigilance case pending against him, vide letters read 1-3 above, for misappropriation of Government money. Hence the DPC held on 4.7.14 has decided that 'Sri.M.Muralidharan is eligible to be included in the select list for the cadre of Additional Director for the year 2014 as No.2, below Sri.E.G.Premkripal and above Sri.A.P.Harilal, subject to clearance from the vigilance angle'. Vide letter read 4th above Government have sought clarification from Sri.M.Muralidharan and vide representations read 5th & 6th above, Sri.M.Muralidharan requested the Government to grant him promotion as Additional Director as only a few months are left for his retirement. As per letter read as paper 8 above, Director General, Department of Economics and Statistics has submitted a proposal for granting temporary promotion to Sri.M.Muralidharan.

Sri.M.Muralidharan had filed OA No.1883/2014 before the Hon'ble KAT and the Hon'ble KAT in its order dated 23.10.14 directed the 1st respondent (Government) to consider and pass orders on Annexure-A14 representation (paper read 6 above) in accordance with law, after affording an opportunity of being heard to applicant, within two months from the date of receipt of a copy of the

order. If for any reason, there is delay in convening the DPC and considering his claim for regular promotion, he may be considered for provisional promotion to the post of Additional Director. As directed by Principal Secretary (Planning) the Additional Secretary, Planning heard Sri.M.Muralidharan on 04-12-2014 and are pleased to promote Sri.M.Muralidharan, Senior Joint Director (Statistics) O/o the Chief Engineer, Irrigation & Administration, Thiruvananthapuram temporarily under Rule 31 (a) (i) Part II, KS&SSRs as Additional Director on Rs.42440-58640 by reverting Smt.V.S.Radhamani who had been promoted and posted as Additional Director (Prices) and Sri.M.Muralidharan is posted as Additional Director (Prices) in the Directorate of Economics & Statistics. Smt.V.S.Radhamani (who is on deputation to CADA), on reversion from PHQs, CADA, Thrissur is posted as Joint Director (Statistics) in the O/o the Chief Engineer, Irrigation & Administration, Thiruvananthapuram (vice Sri.M.Muralidharan promoted).

Action will be taken to include the name of Sri.Muralidharan in the Select List for promotion by placing his case before the adhoc DPC for review of the select list for the relevant year.

The order of the Hon'ble Kerala Administrative Tribunal read as 7th paper above is thus complied with.


