## ORDER

The India Statistical Strengthening Project, a 100% Centrally Sponsored Scheme is being implemented by the Government of India to strengthen the Indian Statistical System. The Government of Kerala and the Government of India signed an MOU for the implementation of this scheme on 16.3.2012. The restructuring and empowering of the Department of Economics and Statistics is one of the activities included in the Project.

The proposal for redesignation / upgradation of posts was included as a matching component in the project and the Administrative Sanction had already been issued by Government. The Director of Economics and Statistics Department vide letter read as 2nd paper above has requested to issue orders upgrading the post of Director to Director General and creating two posts of Director and one post of Additional Director in the Directorate of Economics & Statistics.

In the circumstances stated above Government are pleased to upgrade the post of Director as Director General subject to the condition that the scale of pay of upgraded post of Director General would be corresponding scale of pay of Director, Department of Economics & Statistics, assigned in 2009 Pay Revision Order and to create two posts of Director, (one post for Statistics for Decentralized Planning and the other for Survey, Design, Research & Training) and one post of Additional Director for Technical Coordiantion.

The funds are only for 5 years and therefore the posts upgraded and created are also for 5 years and after this period, these posts will not be allowed to continue utilizing State funds. The expenditure for upgradation and creation of posts will be met from the State share of Rs.334.65 lakhs under the Head of Account '3454--02-112-94 (100% CSS)'.

Government are also pleased to order that the temporary posts - the upgrace newly created posts - in the Department of Economics and Statistics will be filled up by promotion as per the Special Rules as detailed below.
