ORDER

In the Government Order rend above, orders were issued revising the scheme for giving employment assistance to the dependents of Government Servants dying in harness, in super session of all the orders then in force. Government are now pleased to issue the following alternations/modifications/additions to the above orders:

- (1) In the case of married Government servants widow/widower, son or daughter; and in the case of unmarried Government servants, brother or sister alone shall be eligible for the benefit of the scheme. The dependent son, daughter, brother or sister, as the case may will be eligible for employment assistance irrespective of the last whether he/she is married or not.
- (2) Applicants having MBBS or B.Sc. (Engg.) or similar technical qualification will be appointed under the scheme in the usual posts of entry into Government service to which persons with such qualifications are appointed, irrespective of the fast whether such posts are in gazetted cadre or sorry gazetted scale of pay. In other cases appointment shall not be made in gazetted cadre or against posts carrying gazetted scale of pay.
- (3) The stipulation that 50% marks in the S.S.L.C. or graduation is required for being appointed as L.D.C. under the scheme stands revoked. Minimum qualification prescribed for direst recruitment to the relevant posts will be sufficient for giving employment assistance under the dying-in-harness scheme also.
- (4)The stipulation that the appointment once offered will not be allowed to be Changed will stand revoked. However, appointment once accepted will not be allowed to the changed.
- (5)Applicant will have the right to withdraw his/her application at any time before the job is accepted so as to enable another dependent of the family to make his/her application for employment assistance.

- (6) Whenever there is dispute between the salim of two dependents the person Recommended by the widow/widower of the deceased Government servant will be preferred
- 2. Existing item No. 13 in Appendix A to the Government Order rend above will be substituted by the following. "18 Name of the posts for which appointment is sought in the order of preference and the district chosen by the applicant."
 - 3. These orders will take effect from 10.4.1992.
 - 4. The Govt. order read above will stand modified to the above extent only.
