The Government of India have, in their letter dated 7-6-76 covered conveyed the administrative approval to the continuance of the Centrally Spensored Scheme for the catablishment of an Agency for reporting Agracultural Statistics in Kerala during 1976-77 at a total cost not exceeding 8.20 lakhs on the existing terms and conditions. The Government of India have also conveyed their administrative approval for creation and recruitment of the following additional staff for the implementation of the above scheme during 1976-77.

2. Administrative sanction is now accorded for the implementation of scheme at a total cost of not exceeding \$20 lakks during 1976-77 as per the technical programme approved by the Government of India.

- 5. Sanction is also accorded for the creation of the temporary additional posts mentioned at para 1 above for the implementation of the scheme till the end of February, 1977.
- A. According to the approved pattern of assistance of the scheme, the entire expenditure on actual basis subject to the ceiling of the sanctioned amount will be borne by the Government of India. Strict economy will be observed so as to keep the actual expenditure to the minimum.
- 5. The expenditure will be debited to the head of account "304(d)22_T.R.S. of Agricultural Statistics in Kerala (CSS) Plan".
- 6. The Director, Aureau of Economics and Statistics will take timely action in reporting the expenditure to the Government of India so that Contral assistance is released for the scheme in time during the current year itself. The Director, Bureau of Economics and Statistics will also forward monthly reports of progress of the scheme, both financial and physical, to the Government of India and to the Directorate of Economics and Statistics, NowDelhi by the 10th of every month.
