ORDER

There is no Statistical Commission in our State at present. It takes two years to obtain the exact figures of State income whereas in the National level the same is published on quarterly basis itself. Besides, the investment rate, private consumer expenditure figures and the details regarding utilization of State income are not being inferred properly. This creates difficulty in the formulation of Government policies and the analysis for research scholars. As our State is moving forward with time bound projects in the sectors of Agriculture, Industry and Infrastructure, the quality on collection and dissemination of statistical data is imperative.

2. Furnishing of statistics relating to State income, Agriculture, Industry, Infrastructure and Finance in a time bound manner is essential for the effective planning and implementation of the development projects in the State. Moreover, statistics relating to poverty, gender equality analysis, health, education, labour, employment, environment etc needs to be brought out in the public domain. For this, modern statistical techniques in the field of census, sample surveys, Statistics

analysis, Statistical information system etc. are to be utilized. The Member Secretary, State Planning Board as per the letter read above submitted a panel of members for constituting the State Statistical Commission.
