








PREFACE

This report presents the adjusted residential rates on births and deaths in the 30 municipalities, 3 city corporations and in the Guruvayoor Township for the year 1988. The rates are estimated on the basis of the results of spot check survey conducted in the selected units in the Corporations/Municipalities in Kerala. For the calculation, adjustments are made for under registration and events occurring to normal residents outside the town/city. This report has been prepared by the Vital Statistics Unit in the Directorate of Economics and Statistics.



RESIDENTIAL VITAL RATES IN CORPORATIONS AND MUNICIPALITIES - 1988

Introduction:-

Under the Civil Registration System in Kerala, the vital events irrespective of whether it occurred to the normal residents or the outsiders are registered at the place of occurrence. The medical facilities available in the urban areas are comparatively good and they are utilised by the people in the rural areas also. This leads to the registration of high number of events pertaining to the outsiders. The level of under registration though reduced to a considerable extent, still persists in Kerala. The presence of under registration and registration of events to the outsiders stands in the way of understanding the reliable and accurate position on the rate of incidence of births and deaths to the normal residents. So with the intention of understanding the extent of under-registration and arriving at the adjusted residential rates the spot-check survey under the scheme, "strengthening of vital statistical units in Municipalities and corporations for the improvement of Vital Statistics" was introduced. The spot-check results for the year 1988 are presented in the report.

II. Scheme for improvement of vital statistics

The reliable statistics relating to birth and death are very important in developing, planning, especially for taking appropriate action in the field of Health and Family Planning. To get such reliable data, every birth and death should have to be registered without any omission under the rules in vogue. For the purpose, the birth and death registration is made compulsory in the State.

To avoid omission in the registration of vital events, educational efforts are to be made to create awareness among the public on the necessity and importance of registration of vital events. The publication of pamphlets, leaflets, display of boards, exhibition of slides in the theatre etc. are a few among them. The defaulters are also to be suitably fined in accordance with the provisions contained in birth and death registration act and rules. Despite such measures taken, there are deficiencies in the Civil registration data. For the improvement of the vital statistics generated through this source, the spot-check scheme continued in the selected centres as in the previous year.

Objective:-

The objectives of the spot-check scheme are

- i. to estimate the adjusted residential vital rates in the Municipalities and Corporations.
- ii. to ascertain the extent of under registration.

Methodology

During the year 1988, three Corporation, 30 Municipalities and Guruvayoor Township were covered under the scheme. In the Corporations of Thiruvananthapuram, Kochi and Kozhikode, 15 wards each were selected for the conduct of the survey. Similarly in all the Municipalities, except in Kollam and Alappuzha, 15 wards each were selected. In Kollam and Alappuzha 18 wards each were selected. All the ten wards in Guruvayoor Township were selected, for the above purpose. The random sampling technique was adopted for the selection of wards. The Compiler and Research Assistant engaged in the work, visited each household in these selected wards and collected the required data on vital events. The vital events to normal residents enumerated through spot-check comprise the following:-

- i. Events occurring inside the town and registered.
- ii. Events occurring inside the town but not registered.
- iii. Events occurring outside the town registered and un-registered.

Calculation of rate of under-registration

Spot-check results are used for the calculation of the extent of under-registration and estimation of residential vital rates. For the calculation of the percentage of under-registration, the events occurring to persons coming to the town/city to avail themselves of better medical facilities are included.

For the calculation of residential vital rates events occurred to outsiders should be excluded from the total registered events. The registered rates to normal residents are weighted for under registration and further adjusted for events occurring outside the town to normal residents.

III. General finding of the survey

Table I represents the area, population and density of population for the selected Municipalities/Corporations taken for the spot-check survey during the year 1988. As in the previous year, the density of population was highest in Kollam Municipality (8061) followed by Thiruvananthapuram Corporation (7276). As compared to the previous year, the density of population increased slightly in these two centres. This was the general trend in all the Municipalities and corporations except in Thiruvalla. It may be due to the increase in area resulting from the merger of Kuttappuzha Panchayat with Thiruvalla Municipality. The density of population was lowest in Punalur Municipality (1358). The density of population was more than 5000 in all the three Corporations and the Municipalities of Kollam, Thrissur, Thalasserry and Kannur as in the previous year.

Table II shows the number of hospitals and other medical institutions with bed strength available both in the public and private sector. As in the previous year, Thiruvananthapuram Corporation stood first in the case of number of Hospitals in public sector, and Kochi Corporation in the case of hospitals in private sector, during the year under report. The bed population ratio in the three city Corporations estimated was comparatively low during the year under report, which shows that even the three cities in Kerala the medical facilities may not be sufficient in view of the increasing population.

Table III shows the number of burial grounds and cremation grounds both private and public in the Municipalities and Corporations and also the number of registration units in each Municipality and Corporation selected for spot-check during the year 1988. Number of burial grounds and creation grounds are high in private sector. Highest number of registration unit was in Thiruvananthapuram Corporation (15) followed by Kozhikode Corporation (14).

Table IV represents number of registration units with area and population for registration unit. Among the three City Corporations, area was largest in Kochi Corporation (94.88 Sq.Km.). It was followed by Kozhikode (82.67 Sq.Km.) and Thiruvananthapuram (74.93 Sq.Km.). Area per registration units in these Corporations area 47.44 Sq.Km, 5.90 Sq.Km. and 4.99 Sq.Km. respectively. In the case of Municipalities area per registration unit was largest in Punalur (34.60) and smallest in Thrissur (2.10).

Table V represents the registered vital events such as total events and events to normal residents (Viz. live births, still births, infant deaths, maternal death and other death, with male and female breakup) in each Municipality and Corporation. It is seen that live birth to normal residents were maximum (14497) in Thiruvananthapuram Corporation and minimum in Irinjalakuda Municipality (64). Still births and infant deaths to normal residents were highest in Kozhikode Corporation (205 and 346). In the Municipalities such as Neyyattinkara, Changanacherry, Muvattupuzha, Aluva, Perumbavoor, Kodungallur, Guruvayoor Township, Kunnamkulam, Tirur, Malappuram and Badagara from where no still births to normal residents were reported. Infant deaths to normal residents were also not reported from Punalur, Aluva, Guruvayoor Township and Kunnamkulam. In the case of other deaths, events to normal residents were maximum in Kozhikode Corporation (2713) followed by Kochi (2504) and Thiruvananthapuram (1684). Maternal deaths to normal residents were seen reported only in Thiruvananthapuram Corporation (1), Kollam (3) and Irinjalakuda (1).

The data on death according to causes are given in table VI. Heart disease, Cancer and Pulmonary diseases were among the major causes of death in the City Corporations and Municipalities during the year under report.

Results of spot-check Survey during the year 1988 are given in table VII. It is seen that live births and deaths to normal residents enumerated and registered were maximum in Thiruvananthapuram Corporation.

Table VIII shows the details of under registration and occurrence of out side events. The percentage of under registration in respect of birth and death was highest in Neyyattinkara Municipality (40.76) and 36.67 respectively. During the previous year these rates were 27.14 and 18.60 respectively in this Municipality. As in the previous year the percentage of under-registration in respect of birth and death was 'nil' in Chanaganacherry and Tirur during the year under report also. In Thiruvananthapuram Corporation and in the Municipalities Mavelikara, Pala, Perumbavoor, Irinjalakuda, Kondungallur and Chalakudy there was no case of under-registration in respect of birth during the year under report. The percentage of outside registration of birth was highest in Irinjalakuda Municipality (86.62%) and that of death was in Palai Municipality (32.4%).

IV. Adjusted residential vital rates and registered vital rates 1988

For estimation of adjusted residential vital rates, the event occurring to outsiders are excluded from the total registered events. The adjusted residential vital rates and registered vital rates are given in table ~~VII~~^{XII}. The registered birth rate was highest in Thalasserry (40.28) and the same was lowest in Irinjalakuda Municipality (2.40) during the year 1988; while registered death rate was highest in Alappuzha (7.82) and lowest in Palai (2.07).

The adjusted residential birth rate was Maximum in Thalasserry Municipality (49.40) and minimum in Tirur (11.06) during the year under report. The adjusted residential death rate was highest in Kannur (9.47) Municipality and lowest in Malappuram (3.05). On the basis of the above results, the average of the residential birth and death rates in respect of various Corporations and Municipalities in Kerala for the year 1988 was estimated as 23.7 and 5.8 respectively. The method of estimation of residential vital rates is shown in the Appendix.

In Table IX the residential birth and death rates for the last six years from 1983 are compared. There was a fluctuating trend in almost all the Municipalities and Corporations in respect of adjusted residential birth rate except in Cherthala where this rate was decreasing gradually. By taking 1983 as base year, it is seen that in the following Municipalities, adjusted residential birth rate decreased considerably during the year under report. They are Kayamkulam, Alappuzha, Changancherry, Palai, Muvattupuzha, Parur, Irinjalakuda, Guruvayoor, Kunnamkulam, Tirur, Malappuram, Kozhikode, Badagara, Kannur and Kasaragode. In respect of adjusted death rate also the tendency was more or less the same in almost all the Municipalities as in the case of adjusted residential birth rate.

V. Conclusion

The survey has been implemented successfully in the year 1988 also. The survey result reveals that cent percent average in Civil Registration has not achieved during the year under report due to under registration of vital events.

The spot-check in Municipalities and Corporations helps to find out the unregistered events and thereby the concerned authorities can make efforts to minimise the extent of under-registration.

APPENDIX
**Method of Calculation of Adjusted Residential
 Vital Rates**

Residential vital rates can broadly be defined as the rate of occurrence of vital events to the normal residents of an area in a year. The vital events occurring to normal residents enumerated during the spot-check are divided into three categories.

- i. Events occurring inside the town registers
- ii. events occurring inside the town but not registered
- iii. events occurring outside the town registered or un-registered.

For calculation of the percentage of under-registration, the events occurring to persons coming to the town/city to avail themselves the better medical facilities are included and those of normal residents who are going outside the town are to be included.

- I. Percentage of under registration: No.of events occurred to normal residents inside the town but not, registered $\times 100$) - (No.of events occurred to normal residents inside the town registered and not registered).
- II. Percentage of events occurred : (No.of events occurred to normal residents outside the town register- ed and un-registered $\times 100$) - (Total No.of events enumerated and occurred to normal residents inside the town).
- III.Registered Birth/Death rate to: (Total number of Birth/Death occur- red to NR $\times 100$) - (Mid-year population of the town).
- IV. Residential birth/death rate : Registered Birth/Death rate $\times 100$ to NR occurred inside the town - (100%age of Under Registration). (Weighted for under Registration)
- V. Final residential Birth/Death : (Residential Birth/Death rate to NR rate (weighted for outside evnts), occurred inside the town (weighted for under registration) $\times 100$) - (100 percentage of events occurred outside the town to N.R.)


