STATE INCOME OF KERALA - A BRIEF ANALYSIS

The present issue of 'State Income and related aggregates of Kerala' covers quick estimates of State Income for the year 1985-86 and provisional estimates for the years 1983-84 and 1984-85. Estimates for 1970-71 and 1975-76 are final while those from 1980-81 to 1982-83 are revised estimates. Since it takes considerable time to obtain data from various departments/agencies quick estimates of State Income for the latest year could be prepared only on the basis of crude data and hence are liable to significant changes. The estimates for the period beginning 1980-81 published earlier have been revised taking into account the fresh data which have since become available and using the standard methodology suggested by the Central Statistical Organisation. The issue also contains district-wise estimates for the period from 1980-81 to 1984-85 and gross domestic product at current and constant prices up to 1985-86.

2. State income is the income originated within the boundary of the state. Estimates have been prepared according to the methodology suggested by Central Statistical Organisation. These have the same scope, coverage and approach to methodology as in the past.

3. Net domestic product at current prices is roughly estimated at Rs. 6345 crores in 1985-86 against Rs. 5639 crores in 1984-85; that is 12.5% higher compared to the previous year. The per capita income increased from Rs. 2077 in 1984-85 to Rs. 2295 in 1985-86 registering an increase of 10.5%. From 1970-71 to 1985-86, the annual average growth rate of net domestic product and per capita income was 27% and 19% respectively.

4. In real terms ie. at constant prices (1970-71 prices) the State domestic product works out to Rs. 1755 crores in 1985-86 as against Rs. 1690

crores in 1984-85 showing an increase of 3.9%. The percapita income in real terms showed only 2% increase ie. from Rs.622 in 1984-85 to Rs.635 in 1985-86. The annual average growth rate of net domestic product and percapita income during the period 1970-71 to 1985-86 was 3% and 0.5% respectively.

5. During 1985-86, the contribution of the primary sector to net domestic product remained more or less same as in the previous year. It contributed about 42% in both years. However, the share of the primary sector in the total net domestic product of the state has come down from about 50% in 1970-71 to 42% in 1985-86. The contribution of the secondary sector, though showed a slight decrease in 1985-86 increased from 16% in 1970-71 to 20% in 1985-86. The contribution of the tertiary sector remained more or less same during the last few years. It contributed about 38% of the income of the state in 1985-86, as against 34% in 1970-71.

Comparison with All India

6. At current prices the national income in 1985-86 (quick estimates) is estimated at 195707 crores compared to 174018 crores in 1984-85, showing an increase of 12.5 per cent. In Kerala we can see that the same growth rate was prevalent during the period under reference. The State income of Kerala for the year 1985-86 stands at Rs.6345 crores at current prices where as, for 1984-85 it was Rs.5639 crores. At constant prices (1970-71) the total national income in 1985-86 is estimated at Rs.60143 crores as against Rs.57243 crores in 1984-85 showing an increase of 5.1%, in Kerala the rate is only 3.9% over the period. More or less the same trend is noticed in the case of percapita income as well. At current prices the growth rates of percapita income are 10.2% and 10.5% respectively for India and Kerala.

7. The structural composition of the State/National income has undergone significant changes during the last fifteen years. It can be seen that the contribution of the primary sector recorded a set back in Kerala as well as in the country as a whole while that of the secondary sector has gone up steadily during the period. The share of the tertiary sector increased significantly during the fifteen year period.

Gross Domestic Product

8. Gross Domestic Product at current prices is estimated at Rs.6769 crores in 1985-86 and Rs.6022 crores in 1984-85 showing an increase 12.4% over the previous year. At 1970-71 prices Gross Domestic Product accounts for about Rs.1927 crores and Rs.1856 crores respectively for the respective years thus showing an increase of 3.8% over the period.
