



This brochure presents the new series on State Domestic Product in Kerala with base year 1980-81. The new series thus replaces the old series with base year 1970-71. The methodological notes in the introduction gives the reasons for the differences in the two series of estimates.

The provisional estimates of Gross Domestic Product/Net Domestic Product at current and constant prices have already been published in 1988. An attempt has also been made to prepare industry-wise estimates for the period prior to 1980-81 based on the new series and incorporated in this issue.

The new series of Gross Domestic Product/Net Domestic Product are prepared on the basis of the guidelines issued by the Central Statistical Organisation.

I would like to place on record my appreciation to the officers and staff in the State Income Division for their sincere efforts made in bringing out this publication.

Introduction

The new series on state income with base year 1980-81 was introduced in 1988 as per the guidelines issued by the Central Statistical Organisation. Efforts have been made to make use of as much current data as possible to take account of the structural shift between 1970-71 and 1980-81. The structural change occurred due to the availability of current data obtained from latest census, surveys and studies. Some of the important data sources utilised for the purpose are data on working force from 1981 population census, All India debt and investment survey 1981-82, follow up surveys of Economic census conducted by Central Statistical Organisation and integrated sample surveys. The sector wise methodology and source material used in the computation of new series are explained in the following paragraphs.

Notes on methodology

I. Agriculture and allied activities

The Net Domestic Product from Agriculture (proper) Livestock and allied activities except government irrigation system is estimated by using the production approach which involves estimation of gross value of products and by-products and deduction of the value of inputs and consumption of fixed capital. Separate estimates of gross value of output of agricultural crops and Livestock products are prepared, while Gross Domestic Product and Net Domestic Product are worked out for the activity as a whole.

a) Agriculture (proper)

Estimates of area and production of all the major and minor crops are based on crop estimation surveys under Timely Reporting Survey. These figures are used for the estimation of gross value of output. For miscellaneous and unspecified crops, out turn estimates are not available but area figures are available. For plantation crops the production estimates published by the respective commodity boards are used. In the new series, instead of rice, paddy has been evaluated. The out-turn of by-products are estimated by applying the yield rates based on cost of cultivation surveys. The average wholesale prices prevailing in the primary markets during the peak marketing periods are used for evaluating crop outputs and also for by-products.

b) Livestock and Livestock products

For estimating the gross value of output from Livestock products, they are divided into (i) milk, (ii) meat and meat products, (iii) hides and skins, (iv) eggs and poultry meat, (v) dung, (vi) increment in stock, (vii) other products. The production estimates of milk, meat and egg are based on the report integrated sample survey for estimation of milk, egg and meat.

The value of output is worked out by evaluating the livestock products at the corresponding annual average wholesale prices duly deflated for trade and transport margins and rural/urban price differentials. The value of output of meat has been adjusted to slaughtering and preservation of meat in the manufacturing sector.

c) Inputs

To arrive at the Gross Domestic Product from agriculture and livestock, necessary deductions are made for the cost of inputs. The inputs are (i) seed (ii) manure (chemical and organic) (iii) current repairs and maintenance charges, (iv) livestock feed (v) irrigation charges (vi) electricity charges (vii) cost of pesticides and insecticides (viii) market charges and (ix) cost of diesel oil. Cost of seed was estimated using the seed rates supplied by Central Statistical Organisation. For tapioca the seed rate is estimated by using the cost of cultivation survey results of this department.

The cost of chemical fertilizer used were taken from the fertilizer statistics. The cost of repairs and maintenance, irrigation charges, pesticides and insecticides and diesel oil have been supplied by Central Statistical Organisation.

Organic manure is the gross value of dung in the livestock sub-sector.

The livestock feed has been estimated using the Integrated Sample Survey results.

The electricity charges have been worked out from the annual accounts of Electricity Board.

Market charges are estimated at the rates supplied by Central Statistical Organisation.

d) Gross Domestic Product/Net Domestic Product

The Gross Domestic Product is obtained by deducting the total cost of inputs from the gross value. Gross Domestic Product from operation of government irrigation system is also added to obtain the total Gross Domestic Product for the sector. The consumption of fixed capital is deducted from Gross Domestic Product to obtain the Net Domestic Product from agriculture sector.

Estimates at constant (1980-81) prices

For estimation of Gross Domestic Product/Net Domestic Product at constant prices, the output of agricultural crops, by-products, livestock products and inputs are evaluated at 1980-81 prices. From the gross value the cost of inputs is deducted to arrive at the Gross Domestic Product. To this, the Gross Domestic Product from operation of government irrigation system is added up to obtain the total Gross Domestic Product. From this the consumption of fixed capital is deducted to obtain the Net Domestic Product at constant prices.

2. Forestry and Logging

Forestry sector includes (i) forestry and (ii) logging. The forest products are classified into two groups viz. (i) major products comprising industrial wood and fuel wood (ii) minor products comprising a number of heterogeneous items such as bamboo, eucalyptus, sandal wood, ivory etc.

The value of major forest products is evaluated at producers price. The producers price is obtained by adjusting the wholesale prices for trade and transport margins. An allowance of 10% of the value of the recorded production is made to cover all such unrecorded production. The royalty value of minor products is adjusted to arrive at the economic value.

From the gross value, cost of repairs and maintenance and other operational cost is deducted to get the Gross Domestic Product. From the Gross Domestic Product depreciation is deducted to obtain the Net Domestic Product from forestry and logging.

Estimates at constant prices

The out-turn is evaluated at 1980-81 prices to obtain the gross

value of major products at constant prices. The ratio of the recorded value of major products at the current year to the corresponding value at the base year is applied to estimate the value of minor products at constant prices.

From the gross value, cost of repairs and maintenance and consumption of fixed capital are deducted to arrive at the Net Domestic Product at constant prices.

3. Fishing

The activities included in this sector are (i) marine fish landings (ii) inland fish landings (iii) subsistence fishing (iv) gathering of lime shell, sea shell, sea weeds and other products and (v) fish curing viz. salting and sundrying of fish.

The production approach is followed to estimate the Gross Domestic Product/Net Domestic Product.

The estimates of gross value of marine fish landings, inland fish landings and subsistence fishing by non professional fishermen are prepared separately from the data supplied by the Fisheries department.

From the gross value, cost of repairs and maintenance and other operational costs are deducted to obtain, the gross value added. From the gross value added consumption of fixed capital is deducted to arrive at the net value added. Net value added from fish curing and other marine products are also worked out separately and added to obtain the total net value added from fishing sector.

Estimates at constant prices

The output is evaluated at 1980-81 prices to get the gross value at constant prices. From the gross value, the cost of repairs and maintenance is deducted to arrive at the Gross Domestic Product from the gross value added, the consumption of fixed capital is deducted to obtain the net value added. The value added by fish curing in the base year is projected to later years in proportion to the changes in the quantity of fish cured in the current year relative to the base year.

Net value added from fish curing and other marine products at constant prices is also added to obtain the total Net Domestic Product from fishing sector at constant prices.

4. Mining and quarrying

The estimate of income originating in this sector is prepared by production approach. Data on production and prices of minerals furnished in the "Financial Year Aggregates of Mineral Production" published by the Indian Bureau of Mines is used for estimation. Data on minor minerals is taken from the State Geology Department. The gross value added is further adjusted for input value and bank charges. The percentage of consumption of Fixed Capital to Gross Domestic Product supplied by the Central Statistical Organisation is applied to obtain the State Domestic Product. The figures supplied by the Central Statistical Organisation are used as regards Atomic Energy.

The constant (at 1980-81 prices) price estimates are computed on the basis of actual value of major minerals at 1980-81 prices and this ratio has been applied in the case of minor minerals.

5. Manufacturing

(i) Registered sector

Industry-wise value added has been obtained from the Annual Survey of Industries Division of this Directorate. These value added have been further adjusted for imputed bank charges (All India percentage as per National Accounts Statistics). Central Statistical Organisation's figure of Consumption of Fixed Capital was added to the State Domestic Product to arrive at the Gross Domestic Product.

The constant (at 1980-81 prices) price figures are obtained by applying wholesale price index of manufactured articles in the registered sector.

(ii) Unregistered sector

The net value added in this sector has been estimated based on

the National Sample Survey 33rd round survey results combined with the results of sample survey on Directory Manufacturing Establishments 1978-79 of Kerala. The net value added from the above survey results for 19 industry groups for the year 1977-78 has been moved to later years using the following indices.

- (1) Food products (20-21): Value of output of paddy, sugarcane, oil seeds and pulses.
- (2) Beverages, tobacco and tobacco products (22) : value of output of mangoes and tobacco.
- (3) Textiles (23 to 26) : Value of production of cotton and coir.
- (4) Wood and wood products, furniture and fixtures (27) : Value of output of industrial wood.
- (5) Leather and fur products (29) : Value of output of cattle and buffaloe hides and goat and sheep skin.

For the remaining groups including group 28, growth observed in the value added in the Annual Survey of Industries has been used. Central Statistical Organisation's figure of Consumption Fixed Capital was added to the State Domestic Product to arrive at the Gross Domestic Product.

The constant (at 1980-81 prices) price estimates are obtained based on the wholesale price index of manufactured articles in the unregistered sector.

6. Construction

The estimates of value added from construction are derived from the corresponding estimates of value of construction as shown below.

As regards Administrative Departments, Local bodies and Non Departmental commercial Undertakings, accounts or budgets are analysed.

As regards Post and Telegraph, Railways, Central Public Works Department etc. figures are collected from these institutions.

As regards urban residential buildings, rural residential buildings, urban and rural non residential buildings, other construction works including repair and maintenance etc. the detailed survey results of AIDIS 1981-82 published by the Reserve Bank of India is depended. As regards residual

category (private corporate sector) base year estimate is prepared from 'Lal's paper in Reserve Bank of India publication 1965-66. This is moved to later years with the help of construction expenditure (at current prices) in rural and urban residential sectors to obtain the estimates at current prices.

To the Net Value Added, the Consumption of Fixed Capital figure supplied by the Central Statistical Organisation is added to arrive at the Gross Value Added.

The constant (at 1980-81 prices) price estimates are obtained by moving the base year estimates using the index based on wages of skilled workers (rural and urban).

7. Electricity, gas and water supply

Electricity

The estimates under this sector are prepared based on the data obtained from the profit and loss account and the balance sheet of the Kerala State Electricity Board. Gross Domestic Product has been estimated as an aggregate factor payment such as compensation paid to employees including salaries and wages, money value benefits, Director's fee, interest, rent and surplus and depreciation. Defferred revenue expenditure and intangible assets appearing in the balance sheet has been adjusted in the Gross Domestic Product estimates. In respect of private licencees the details are collected from Annual Survey of Industries schedules.

The constant (at 1980-81 prices) price estimate has been arrived at on the basis of wholesale price indices.

Gas

The estimates of Gobargas has been prepared based on the data obtained from the Kerala Khadi and Village Industries Commission. The production and value of LPG have been supplied by the Central Statistical Organisation. As separate Consumption Fixed Capital for gas sector is not available, Gross Domestic Product is treated as State Domestic Product for this sector.

The constant (at 1980-81 prices) price estimate is arrived by using the ratio of value of LPG at 1980-81 prices to current prices.

Water Supply

The estimates of State Domestic Product has been arrived at by adopting the income approach. Separate estimates have been prepared for private and public sector. In the case of public sector total salaries paid to the employees engaged in water supply sector, as supplied by all the Municipalities and Corporations have been taken as value added.

From the total working force of water supply sector in urban area of the 1981 population census, the public sector working force collected from Municipalites/Corporations has been subtracted to get the private working force in urban area. Number of workers in rural areas available from population Census (1981) has been treated as private rural working force and this has been moved to subsequent years by taking the annual growth rate of 1971-81 census results. Per worker compensation of employees in urban area is taken as average of all the categories in urban areas and of the lowest category for rural areas.

To arrive at the total net value added of water supply, value added in public sector, total wages in private sector and operating surplus as available from the Annual Survey of Industries for this activity are added. To the Net Value Added thus obtained, Consumption of Fixed Capital is added to get the Gross Value Added.

The estimates at constant (at 1980-81 prices) prices are obtained by applying the index based on average compensation per worker as obtained from the Municipalites/Corporations.

8. Transport, Storage and Communications

(1) Railways

The estimates are supplied by Central Statistical Organisation.

(2) Transport by other means and storagea) Mechanised Road Transport

Public Sector:- Net value added from mechanised road transport in the public sector is worked out annually, using the results of analysis of profit and loss statement of Kerala Road Transport Corporation.

The constant price estimates are obtained by moving the value added for 1980-81 with the index of number of workers (KSRTC)

Private sector:- Gross Value Added/Net Value Added for this sector is worked out by multiplying working force with Gross Value Added/Net Value Added per worker for the respective years category-wise. The category-wise working force 701, 702, 703 of NIC 70 is worked out by projecting the working force (as on 1-10-80 based on 1981 census) with the category-wise indicator of number of vehicles registered. State-wise public sector working force is subtracted to get the data for private working force. The private sector working force is divided into rural and urban using the same proportion as observed in 1981 census working force. Value added per worker for the respective category for 1980-81 is worked out on the basis of results of enterprise survey 1983-84, for rural and urban areas separately. Gross Value Added per worker and Net Value Added were available from this survey have been brought back and moved forward with the help of index number of consumer price for urban non-manual employees for urban areas and index of rural skilled workers for rural areas.

The value added at constant price is obtained by moving the 1980-81 value added with the index number of workers (1981 census) projected with the help of number of vehicles.

b) Non-Mechanised Transport:- It covers non-mechanised road transport (NIC 704, 705, 706) supporting services to land transport (NIC 708) unrecognised water transport and services incidental to transport (NIC 730). The gross value added and net value added for transport by other means for the base year 1980-81 is prepared using 1981 census working force and Gross Value Added and Net Value Added per worker. Gross value added and Net value added per worker as obtained from 1983-84 enterprise survey were brought

back to 1980-81 using the consumer price index of urban non-manual employees and index of rural skilled workers for urban and rural areas respectively. The estimates of gross value and net value added for subsequent years are worked out by carrying forward the base year estimates with the help of relevant index of gross value of output of commodity producing sectors at current prices.

The value added at constant price is obtained by moving the value added for 1980-81 with the index of gross value of commodity producing sector at constant price.

c) Storage and warehousing:- For storage and warehousing public sector estimate is worked out by analysing the annual accounts of Kerala State Warehousing Corporation. For Private sector, the value added obtained from National Sample Survey 29th round is used. The base year estimate is brought forward using the index of gross value of commodity producing sector valued at current prices.

For the estimates at constant price, the data on storage capacity is made use of.

d) Water Transport:- Estimates of income from Kerala Water Transport Corporation, Water Transport Alleppey are obtained by analysing the annual accounts of the respective water transport undertakings. Similarly income from Cochin Port Trust and other ports are worked out annually by analysing the relevant accounts and budget.

Value added at constant price is obtained by using the index of employment.

(3) Communication

The estimates at current and constant prices are supplied by Central Statistical Organisation.

9. Trade, Hotels and Restaurant

The estimates of gross value added have been prepared separately

for public and private sector. For public sector the value added is obtained by analysing the annual accounts of state trading enterprises.

The estimate in the private sector 1978-79 is prepared by interpolating the results of Directory Establishment Survey 1979-80 (trade hotels and restaurant) and National Sample Survey 34th round. The estimate for base year 1980-81 and then to other years is obtained by moving the value added with the index of gross value of commodity producing sector valued at current prices.

The estimate at constant price is worked out using the index of gross value of commodity producing sector at constant prices.

10. Banking and Insurance

State share supplied by Central Statistical Organisation.

11. Real Estate and Ownership of Dwelling

(a) Ownership of Dwelling

The gross rental is estimated separately for rural and urban areas. The National Sample survey Organisation in 38th round collected data on percapita monthly rent in urban areas in respect of Katcha, Semi-pucca and Pucca houses. State-wise average percapita monthly rent has been presented separately for rental and owner occupied houses together with percentage of households living in rental houses. Using proportion of the two categories as weighted average per-capita monthly rent has been calculated in respect of all categories of houses to represent rent in urban area in 1983.

Gross rental has been calculated by multiplying rent percapita by population. Gross rental per dwelling has been obtained by dividing the gross rental by estimated number of dwelling. The urban rural proportion of the rental per dwelling collected from Municipalities, Corporations for urban and Panchayats for rural) is applied to get the rental per dwelling of rural residential houses.

The number of dwellings are collected from Municipalities and

Corporations for every year for urban areas and for rural, estimated from the sample data collected. The increase in house rent compiled for urban rural manual employees (Central Statistical Organisations' time scale) is applied to get the rental/dwelling of urban area for the subsequent years.

Value added at constant price is obtained by using the current constant ratio of all India estimate (CSO).

(b) Real estate

The net value added in respect of Real estate is worked out annually by analysing the balance sheet of the joint stock companies.

(c) Business service

The estimates are prepared following the same approach and same source of data as for other service (other than education and sanitary service)

12. Public Administration

The estimates are prepared separately for State Government, Central Government and Local bodies consisting of Municipalities, Corporations and Panchayats. For State Government the estimates are prepared in terms of compensation to employees obtained from the budget documents of the State. For the Central part the estimates are supplied by Central Statistical Organisation. Regarding local bodies the data on expenditure on wages and salaries have been collected from all the Municipalities, Corporations and Panchayats.

Value added at constant price is worked out using the all India current constant ratio computed by Central Statistical Organisation.

13. Other services

(1) Education Research and Scientific Services

Value added in respect of recognised educational institution is estimated by taking the expenditure on salaries and wages of teaching and non-teaching staff. For un-recognised educational institution 9.48% (1983-84 enterprise survey result) of recognised educational institution is taken.

Value added at constant price in educational sector is obtained by using the index of teacher student ratio.

(2) Medical and Health Services

(a) Public sector:- Total expenditure on medical and health service on Public sector have been obtained from the budget of the State.

(b) Private Sector:- The value added per worker for 1980-81 to 1983-84 is arrived at by interpolating the results of National Sample Survey 34th round OAE survey results and 1983-84 enterprise survey results. Per worker value added for rural and urban is obtained by using the wage rate of skilled workers and consumer price index of urban non-manual employees. The working force is worked out using 1971 and 1981 census results and the growth rate observed.

The data on working force for non-government sector is obtained therein as a residual subtracting public sector employment from total working force.

(3) Sanitary Service:- For sanitary service the estimates for public sector is worked out from the Municipal data collected each year.

(4) Other services:- For rest of the other services namely legal services, religious and other community service, personal service and services not elsewhere classified the value added per worker is obtained similarly for medical and health service (private). Value added at constant prices for medical and health service, Sanitary service and other service is obtained by using the index on number of workers.

State Income of Kerala - A Brief Analysis

The revised estimates of State income upto 1985-86 and Quick estimates for 1986-87 with base year 1970-71 have been published in 1987 along with a brief analysis of the results. The provisional estimates on new series have already been released in 1988 and incorporated in the recent publications. This brochure the first issue in the new series, with base year 1980-81 covers the period 1980-81 to 1987-88.

The magnitude of the changes in this series can be seen from the following tables.

The difference in the current price estimates is due to the structural changes occurred due to the availability of current data and improvements in the methodology.

A comparison of constant price estimates shows the change occurred in the economy due to price fluctuations over a period of 10 years as a result of shifting the base year from 1970-71 to 1980-81.

The sector-wise changes effected have been explained in the methodological notes.

The above table reveals that there is substantial increase in the Gross Domestic Product due to the adoption of fresh data based and change in methodology. But so much difference has not been reflected in the estimates of Net Domestic Product (Table 1). This is due to the revised methodology adopted for estimating the consumption of fixed capital.

Net Domestic Product equals Gross Domestic Product less consumption of fixed capital. Thus the estimates of Net Domestic Product in the new series would normally have increased by the same amount as that of Gross Domestic Product but for the fact that the procedure of estimation of consumption of fixed capital has been changed resulting in higher estimates of consumption of fixed capital.

The changes observed in the two series of estimates at state and National level shows more or less the same trends. The data base and methodology used in the computation of State income on new series as stated earlier are based on the guide lines issued by the Central Statistical Organisation.

District Income:

District-wise estimates of Net Domestic Product and per capita income for the years from 1980-81 to 1986-87 at current and constant prices on new series are prepared and the relevant statements appended.
