

P R E F A C E

In January 1977, estimates of District Income of Kerala for the years 1970-71 to 1974-75 has been published for the first time. The second in the series was published in November 1977 presenting the district income estimates of Kerala for the years 1970-71 to 1975-76. In February 1980, the State and District Income Estimates of Kerala for the years 1970-71 to 1977-78 was published.

This issue (fourth in the series) presents the estimates of **district income of Kerala for the years 1970-71 to 1984-85** both at current and constant (1970-71) prices. Partial revision has been made in the earlier estimates depending on the availability of further refined data and on the receipt of revised working force estimates. The estimates for the years 1983-84 and 1984-85 are provisional.

These estimates are prepared following the standard methodology suggested by the Central Statistical Organisation. The estimates are prepared separately for all the 13 sectors and presented in the tables given in this issue.

This report was prepared by the State Income Division of this directorate.

This publication may be useful to the planners and research workers who are interested in the study of the regional differentials of the State Income of Kerala.

DISTRICT INCOME OF KERALA

1.1 Introduction

District income is one of the important yardsticks for measuring the economic development of the districts. These estimates help in locating the economically backward areas and also facilitate in framing of policies and programmes aimed at achieving balanced regional development.

This directorate is preparing the State Income of Kerala on the standard methodology suggested by the Central Statistical Organisation. The concept adopted in the preparation of **District Income** is the same as that adopted in State income estimation viz. the concept of net domestic product at factor cost. According to this concept, district income includes all the income originating within the district irrespective of the fact that the income accrues to persons residing inside, or outside the district. The estimates have been prepared adopting the same industrial classification as is used for the estimation of State Income. The district income estimates both at current prices and constant (1970-71) prices have been computed.

1.2 A brief analysis

District income both at current and constant (1970-71) prices for the years 1970-71 to 1984-85 has been presented herein in the set of tables.

So far as the district income is concerned Ernakulam district stands first during all the years 1976-77 to 1984-85. Quilon district occupies the first place during the years 1970-71 to 1975-76. The net domestic product of Ernakulam district for the year 1984-85 was Rs.791 crores at current prices and Rs.221 crores at constant (1970-71) prices. Idukki district has the lowest income upto the year 1980-81. From 1981-82 Wynad district occupies the above position. The income from Wynad district during the year 1984-85 was Rs.169 crores at current prices and Rs.52 crores at constant (1970-71) prices.

In 1984-85, the contribution of income from primary sector is maximum in Cannanore district. This accounts 12.22% of the State's Income from that sector. The next rank is for Ernakulam district. The primary sector contributes 10.11% of the State's income from that sector in 1984-85. The lowest position is occupied by Wynad district (4.11%). The contribution of primary sector to State's primary sector in Wayanad district is 4.11% in 1984-85.

In respect of secondary sector Ernakulam district contributes the largest share to states income from that sector. This trend is consistant during all the years. Contribution of Ernakulam district to the income from secondary sector increased from 18.50% in 1970-71 to 25.05% in 1984-85. Income from secondary sector in Ernakulam district during 1984-85 was about Rs.293 crores at current prices. Ernakulam has the highest concentration of capital intensive industries in the state. This may be the reason for pushing up income from secondary sector of this district. The lowest share of income from secondary sector is from Wayanad district.

As in the case of secondary sector, Ernakulam district contributes the largest share of income from tertiary sector also. This accounts 12.32% of the state's income from tertiary sector in 1984-85. Trivandrum district stands second, contributing 12.14% of the total income from tertiary sector during 1984-85. As in the case of the other two sectors, the lowest share of income from tertiary sector is from Wayanad district.

Percapita income providing a rough measurement of income levels. Ernakulam district shows the highest per capita income. This trend is exhibited from 1980-81 onwards. In 1984-85, the per capita income of Ernakulam district was Rs.2926 at current prices. The second position is occupied by Wayanad district with a per capita income of Rs.2858 at current prices. Wayanad district has the lowest position in the ranking of districts by population. This may be the reason for pushing up the per capita income of this district. Malappuram district has the lowest per capita income of Rs.1297 at current prices in 1984-85. This trend is seen during all the years. In 1970-71, Quilon and Idukki districts have the highest per capita income of Rs.658 each followed by Kottayam district with Rs.652. In 1975-76, the per capita income of Quilon district was Rs.1180 at current prices. The second position is occupied by Idukki district with a per capita income of Rs.1162 at current prices. In 1980-81 also Idukki district stands second with a per capita income of Rs.1647 at current prices.

Kottayam, Idukki, Ernakulam and Wayanad districts exhibit a higher per capita income than the state per capita income for all the years. The per capita income in Trichur, Malappuram and Cannanore districts is lower than the State per capita income consistently during all the years.

1.3 Methodology

Computation of district income

The computation of district income is done basically in two ways (1) where the data are available at district level, district wise income was estimated independently and (2) where it is not available the State totals were allocated among the districts on the basis of appropriate indicators.

1. Agriculture: District-wise income from agriculture and allied activities is estimated following the production approach. The computation is done independently for each district. The gross value of output is obtained by evaluating the district-wise out turn of crops at their primary wholesale prices at the district level during the peak marketing period. For estimating the production of by-products, yield rates for the state is applied to the district wise area. For other crops and miscellaneous non-food crops, the value of yield/hectare for the State is used for district also. The total out turn of livestock products are estimated using the yield rates and district wise livestock population under each category. The products are evaluated at their wholesale prices published by Animal Husbandry department, after making necessary adjustments for trade and transport margins and rural/urban price differentials. From the gross value of output from agriculture, Animal Husbandry and hunting and trapping, the value of inputs is deducted to arrive at the gross product.

The inputs like seed, livestock feed, etc. are worked out independently and for other inputs and gross product from operation of Government irrigation system and depreciation, State-wise estimates are allocated among the districts applying appropriate indicators.

The gross product from operations of Government irrigation system is added to arrive at the total gross product for each district.

The cost of depreciation has been deducted from the gross product to get the net product for each district.

2. Forestry & logging: Methodology followed is the same for state estimates and district estimates of NDP from the sector. The division-wise area under forest and forest produce are available with the state forest department. The yield rate of each forest product is estimated from the above data. The out turn of each item is worked out using these yield rates and district wise area under forest. The product is evaluated at their prices from the gross value so obtained the cost of inputs and depreciation are deducted to obtain the NDP for each district.

3. Fishing: District-wise estimates are prepared independently. District wise out turn and value of marine and inland fish landings are collected and supplied by Fisheries department. For other marine products, State estimates are allocated among the district by applying the ratio of marine fish landings in the districts. Cost of repairs and maintenance and depreciation are worked out at the rates used for preparing the state estimates.

From the gross value cost of repairs and maintenance and depreciation are deducted to arrive at the NDP for each districts.

4. Mining & quarrying: The district-wise break up is obtained based on the value of production of minerals in each district obtained from the State Geology department.

5. Manufacturing (registered): (1) The state domestic product is allocated to the districts on the basis of district-wise net value added obtained from Annual Survey of Industries.

(2) **Manufacturing (unregistered):** The state domestic product is allocated to each district on the basis of the working force in unorganised manufacturing sector in each district.

6. Construction: The state domestic product is apportioned to the districts on the basis of working force (construction) in each district.

7. Electricity: The state domestic product is apportioned to the districts on the basis of the working force in Electricity in each district.

8. Water supply: The State domestic product is allocated to the districts on the basis of the number of workers in each district.

9. Transport storage and communication:

- a) Railways
- b) Transport by other means and storage
- c) Communication

(a) Railways: For railways district wise track kilometre data are used for allocating state estimates

(b) Transport by other means and storage: For public sector mechanised Road Transport (passenger transport) the state income is apportioned to the district on the basis of number of bus schedule. In respect of private sector the income is allocated according to average value added per worker. For non-mechanised road transport the state level income is apportioned to districts on the basis of the census working force. As regards the income from water transport the data is available at district level for public sector. For storage and ware housing (public sector) the district wise allocation is done on the basis of deposits in the centres in each district. For private sector the SDP is apportioned to the districts on the basis of working force.

(c) Communication: For communication the SDP is apportioned to the districts on the basis of working force.

10. Trade hotels and restaurants : The income from trade hotels and restaurants has been apportioned to district on the basis of working force.

11. Banking and insurance: For this sector income has been allocated to districts on the basis of a combined index of number of offices and amount of advances and deposits.

12. Real estate and ownership of dwellings: The income from ownership of dwelling is available separately for urban and rural areas of each district. District-wise estimate is prepared using these data.

13. Public administration: The income from this sector relating to central and state administration is allocated on the basis of working force. Regarding local bodies (Panchayats, Municipalities & Corporations) the data is available at district level.

14. Other services: Except for education the State estimates is apportioned the district on the basis of working force. As regards educational sector data for estimating district income from University and Medical education are available at district level. For collegiate and technical education the district wise allocation is done on the basis of number of institutions in each district. For general education the State level estimate is apportioned to districts on the basis of working force.
