The estimates prepared separately for all sectors are prescribed in the tables given in this issue.

District-wise breakup of new series GSDP & NSDP and Per capita Income at Current and Constant (1999-00) prices for the period from 1999-00 to 2005-06 are also presented in this publication.

DOMESTIC PRODUCTS - IN NEW BASE (BASE YEAR 1999-2000)

INTRODUCTION

The development of official estimates of national income and related aggregates to meet the requirements for planning and policy purposes began after Independence. Recognizing the need for providing estimates of national income on a regular basis, Government of India set up a High Powered Expert Committee in 1949 known as 'National Income Committee' under the Chairmanship of Prof. P.C. Mahalanobis. This Committee provided the estimates of national income for the entire Indian Union for the first time. The estimates of national income and details of methodology adopted by the Committee were published in the First and Final reports of the National Income Committee brought out in April 1951 and February 1954 respectively. In accordance with the methodology and the pattern of presentation recommended by the National Income Committee, the first official estimates of national income were prepared by the Central Statistical Organisation (CSO) with base year 1948-49. These estimates at constant (1948-49) prices along with the corresponding estimates at current prices and the accounts of the Public Authorities were published in the publication, 'Estimates of National Income in 1956'.

BASE YEAR

The period that provides the weights for an index is described as the base period.

WHY WE CHANGE BASE YEAR

To capture the Structural Changes in the Economy, to incorporate results of long term Surveys (as they are not included in between), to incorporate latest International standards, to make methodological

improvements, to realistically measure the real Growth in the Economy, we change the Base Year time to time.

THE BASE YEARS

With the gradual improvement in the availability of basic data over the years, a comprehensive review of methodology for national accounts statistics has constantly been undertaken with a view to updating the database and shifting the base year to a more recent year. As a result, base years of the National Accounts Statistics series have been shifted from 1948-49 to 1960-61 in August 1967, from 1960-61 to 1970-71 in January 1978, from 1970-71 to 1980-81 in February 1988 and from 1980-81 to 1993-94 in February 1999. In line with this practice, the CSO introduced the *New Series* of National Accounts Statistics with 1999-2000 as the base year, on 31st January.

CHOICE OF 1999-2000 AS THE NEW BASE YEAR

In the past, National Accounts Statistics have mostly been revised decennially changing the base to a year synchronizing with the year of decennial Population Census. It was primarily because in the base year estimates, the information on work force has played an important role and workforce estimates can be obtained from the Population Census which are conducted decennially in the years ending with 1. As a sequel to this sequence, the previous series of National Accounts Statistics should have been with the base year 1990-91. At that time, it was observed that the data on work participation rate (WPR), captured by the National Sample Survey Organisation (NSSO) was better than the one estimated through the Population Census. Accordingly, the CSO

used the workforce estimates based on National Sample Survey (NSS) workforce participation rates from the NSS 1993-94 (50th Round) survey results, and revised the base year of national accounts to 1993-94.

In continuation with this practice, the new series of national accounts released on 31st January, 2006 adopted 1999-2000 as the base year, as it has used the data on WPR from the NSS 55th round Quinquennial survey on Employment and Unemployment, conducted in 1999-2000. In the new series, the WPR data has been used in conjunction with population data of the Population Census, 2001.

ADDITIONS IN COVERAGE UNDER NEW SERIES

The improvements in terms of coverage in the new series in the GDP estimates have mainly been inclusion of production of (i) salt through seawater evaporation, (ii) betel leaves, (iii) toddy (iv) goat milk (in 16 States/UTs), buffalo milk (in 5 States/UTs) and camel milk having economic value and not presently covered in the production data, (v) duck eggs (in 15 States/UTs), and (vi) meat production from unregistered slaughtering in the States where the same is presently not covered in the production estimates. Further, capital expenditures incurred on (i) seven new tree crops during the gestation period, and (ii) installation of wind energy systems, are included in the estimates of output of construction sector, as well as in the capital formation. A new category of 'valuables', covering the expenditures made on acquisition of valuables namely gold, jewellery, etc. has been included in the gross capital formation, but as a separate category outside the Gross Fixed

Capital Formation (GFCF) and Change in Stocks, in line with the recommendations of 1993 SNA.

Besides the above, economic activities like (i) other private communication, (ii) renting of machinery and other equipment without operator, (iii) computer related activities in unorganized segment, (iv) coaching centres, (v) social work with accommodation, and (vi) recreation and cultural and supporting activities, have been taken into account as per the latest available data from the NSS 55th and NSS 57th rounds. These activities were not adequately captured in the earlier series, but are explicitly defined in the National Industrial Classification, 1998, according to which the NSSO collected the data in these Rounds.

AGRICULTURE

The estimates of Gross State Domestic Product of this sector are compiled by the "production approach" except the operation of Government Irrigation System for which the income approach is followed. The estimates of area and production of all crops including fruits and vegetables are taken from Directorate of Economics & Statistics and some other recognised institutions. The concerned prices are also taken from DES and from some identified agencies. The estimates of output for miscellaneous and unspecified crops are obtained by applying the appropriate average value of yield per hectare. Average Wholesale Prices prevailing in the Primary Markets are taken for evaluation of Gross Value of Output.

Inputs:

Seed: Seed rates are supplied by CSO based on the cost of cultivation studies.

Organic Manure: The output of dung manure in Livestock sector is taken as an input in the Agriculture sector.

Chemical fertilizers: Value of Chemical fertilizers supplied by CSO is taken.

Irrigation Charges: These estimates are culled out from the Budget Documents (Irrigation Department).

Market Charges: Data on market charges for various agricultural commodities supplied by CSO have been used

Electricity: Electricity supplied to Agriculture sector is taken as input from annual accounts of KSEB.

Consumption of Diesel Oil: The estimates are based on consumption of diesel oil per engine/tractor as collected through cost of cultivation studies supplied by CSO.

Repairs and Maintenance: The estimates are prepared by using the All India Debt and Investment Surveys (AIDIS) results.

Pesticides and Insecticides: The value estimates through quantity dispatched to the States as supplied by CSO are taken.

At present these input values are provided by CSO

Area irrigated by canals.

This should be added to the gross value of output of agriculture after deducting the value of inputs. The State level value of contribution by Government Irrigation System is provided by CSO.

From these Gross Value Output and then SDPs are derived

LIVESTOCK

The estimates of GSDP of this sector are compiled by following the "production approach". The data on the production of milk, meat and egg are collected from the Animal Husbandry Department. The yield rates of various meat products are supplied by the CSO. Livestock population projections based on latest Livestock Census has been used to estimate increment in livestock, meat products and dung production. The annual number of incoming animals, annual wholesale prices of livestock and livestock products etc are taken from Animal Husbandry Department to estimate the value added.

Item wise estimation procedure

Milk

The Milk Production (Cow and Buffaloes) are obtained from integrated sample survey (ISS) by Animal husbandry department annually. The production is multiplied with the average whole sale prices to obtain the value of milk.

Meat

It is broadly divided in to 5 types Cattle, Buffalo, Sheep, Goat and Pig. The meat production is derived by using rates & ratios from ISS & Quinquennial surveys conducted by Animal Husbandry Department. The Average whole sale prices of meat are obtained from the AHD.

Meat Products

The Meat products are Heads, Legs, Glands, Fats, Guts, Bones, Horns, Hides and Skins etc.

Dung Estimation

The total dung production consists of dung used as manure, dung used as fuel and wastage. The quantity of dung production is estimated with bovine (Cattle and Buffalo) population.

Egg Consumed

The wholesale egg prices are obtained from prices unit of DES and production from AHD. As per the ratio maintained above the egg production estimates will be arrived and multiplied with prices to arrive the Value of egg production

Poultry Meat (In No's)

The number of eggs produced in a year is collected from directorate of Animal husbandry. According to CSO, 83% of eggs are consumed and remaining 17% are being hatched. Only 50% of hatching eggs would be survived.

The quantity of poultry meat is the sum of (i) poultry killed out of survived from hatching in present year and (ii) Poultry killed out of surviving from last year poultry i.e., estimated poultry from livestock censuses. According to CSO 1) all chickens and ducklings are killed 2) 50% of Hens, Cocks, Ducks and Drakes are killed 3) 37.5% Other poultry are killed.

Honey

It is a new item added in the state

Input Estimation

Input consist of 1) Feed 2) Marketing Charges 3) Maintenance & Repairs Livestock feed consist of Roughages and Concentrates.

Using these data and rates and ratios provided (presently) by CSO the GVA/SDP of Livestock is estimated

FORESTRY / LOGGING

Estimates of Gross State Domestic Product of this sector are prepared by following the production approach. GVO is estimated separately for (1) Industrial wood, (ii) Fuel wood and (iii) Minor forest products. Estimates on the above components are based on data received from Forest Department. 10% of the recorded production is

taken as unrecorded production. These estimates are then inflated by 1.06 per cent as supplied by the CSO to account for consumption of fuel wood by the industries and on funerals. Value of inputs is taken as 10 per cent of the value of output. Estimates of Gross State Domestic Product so prepared are further netted for estimates of consumption of fixed capital to arrive at Net State Domestic Product.

FISHING

Fishing sector is broadly divided into 3 sub sectors i.e., Marine fish, Inland fish and Prawn. Estimation of GSDP of Fishing sector is prepared by using the 'Production Approach. The data on production and prices of Marine fish, Inland fish, Prawn/shrimps, sun dried fish, salted fish and frozen fish is furnished by the Fisheries Department in the prescribed format. The GVA of subsistence fish is estimated as 12.5% of the GVA of inland fish. The Repairs & Maintenance expenditure is taken as 22.5%, 10%, 22.5%, 1% and 1% of the values of Marine fish, Inland fish, Prawn, Subsistence fish and Salted fish respectively.

MINING / QUARRYING

This sector covers the economic activities of production of all minerals, which are extracted in the state from soil as solids, liquid or gas. Estimates of GVA in this sector are compiled following the production approach by calculating the value of output of each mineral at state level and deducting the value of corresponding input there from. Mineral wise data on output of all minerals (except minor minerals) are supplied by Indian Bureau of Mines (IBM), Nagpur. The information on output of minor minerals is collected from State Mining and Geology Department.

The Gross Value of output is derived by multiplying the production of Major and Minor minerals by the existing price prevailing in the market.

MANUFACTURNG REGISTERED

The contribution of manufacturing (registered) sector is estimated at the state level Industry group (NIC code) wise. GVA of manufacturing registered sector is estimated on the basis of "Annual Survey of Industries". It covers one fifth of Industries every year by which all industrial units will be covered in a time span of five years. Presently Kerala uses the data supplied by the CSO. Production Approach is followed while estimating the GSDP in this sector.

MANUFACTURNG UN-REGISTERED

The estimates of GVA, for the units belonging to Small Scale Industries sector, have been compiled by using the estimates of GVA per worker based on the state wise results of All India Census on Small Scale Industrial Units (SSI) with the corresponding work force. The GVA per worker inflated for the base year using Wholesale Price Index and the workforce extrapolated to the base year after excluding the ASI portion. Presently the data supplied by the CSO is used in Kerala.

ELECTRICITY, GAS AND WATER SUPPLY

Electricity, Gas and Water Supply Sector of GSDP consists of 3 Sub Sectors i.e., Electricity, Gas and Water Supply. Estimation of GSDP of Electricity, Gas and Water Supply Sectors are based on Income approach.

ELECTRICITY

GVA is arrived by analyzing the annual accounts of KSEB. The value added estimates of Central Undertakings in the State (NTPC & PGC) is provided by C.S.O. Income approach is followed here.

WATER SUPPLY

The estimates of public sector Undertakings are culled out from annual accounts of KWA budgets. Income approach is followed

GAS

State level Value Added from this sector is provided by CSO as a whole

CONSTRUCTION

The estimates of GVA of this sector are being prepared independently for the following categories with Expenditure Approach. The expenditure incurred on Cement, Steel, Bricks, Sand and wages of Construction workers are considered for this sector. The above said items of data are collected from the districts.

A. Public Sector of the State is consisting of:

- Administrative Departments and Departmental Enterprises.
- Non-Departmental Commercial Undertakings (NDCUs)
- Railways and
- Communications

B. Household Sector is divided into

- Rural Residential Buildings
- Urban Residential Buildings
- Rural and Urban Non-Residential Buildings

C. Private corporate sector

This sector consisting of other private un-incorporated enterprises and private non-profit institutions including quasi corporate bodies.

Item Wise Estimation Procedure

PUBLIC SECTOR

Administrative Departments and Departmental Enterprises: - The Expenditure on New Construction, repairs and Maintenance and Staff

cost of all Administrative Departments and their Departmental undertakings are derived from the Budget Document.

Local Bodies: - The expenditure on new Constructions, repairs & Maintenance and Staff cost of all Local Bodies are derived from the concerned Local bodies consolidated annual accounts (Presently provided by CSO)

NDCUs(Non-Departmental Commercial Under takings):- The expenditure on new Constructions, repairs & Maintenance and Staff cost of all Non-departmental undertakings is derived from the concerned budget annual accounts is being used(Presently provided by the CSO)

Railways: - The Central Statistical Organisation (CSO) provides the GVA under this sector for the State as a whole.

Communication: - Central Statistical Organisation (CSO) provides the GVA under this sector for the State as a whole.

Central Government Administration & DCU's (Departmental Commercial Under takings):- Central Statistical Organisation (CSO) provides the GVA under this sector for the State as a whole.

HOUSEHOLD SECTOR

Rural Residential Buildings & Urban Residential Buildings

The total Expenditure under this sectors are derived in the State using the indices provided by the CSO

Rural/Urban Non-Residential Buildings

The total Expenditure under this sectors are derived in the State using the indices provided by the CSO

RESIDUAL SECTOR

The Central Statistical Organisation (CSO) furnishes the GVA under this sector for the State as a whole.

TRANSPORT BY OTHER MEANS AND STORAGE

A. TRANSPORT

Income Approach is followed for estimation of GSDP of Transport by other means and storage. Transport by other means and storage Sector is broadly divided into 2 Sub Sectors i.e., Public part and private part. Here Workforce (WF), Growth Rate (GR) and Value Added Per Worker (VAPW) tools are used to derive GVA and then SDP

Public Part

The analysis of Annual Accounts provides the estimates for KSRTC & KSIWTC

Private part

It is broadly divided in to two sub Sectors; Mechanised transport and Non- Mechanized Transport.

Mechanised Transport

The data on Vehicles for deriving GVA is provided by Commissioner of Transports.

Air Transport

The CSO, Government of India is estimating the gross value added at National level and apportioning for the States based on certain indicators.

Water Transport

The CSO, Government of India is estimating the gross value added at National level apportioning for the States based on certain indicators.

B. STORAGE

Estimates of central warehousing are based on the analysis of annual accounts of Central Warehousing Corporation and is provided by CSO.

TRADE, HOTELS AND RESTAURANTS

Trade, Hotels and Restaurants Sector consists of Trade and Hotels & Restaurants. Income approach is used for estimation of GSDP of this Sector. Here Workforce (WF), Growth Rate (GR) and Value Added Per Worker (VAPW) methods are used to derive GVA and hence SDP

A. TRADE

This Sector is divided into two parts i.e. Public Part and Private Part

Public Part

It is again divided into two, Central and State and WF, GR, VAPW in these parts are provided by CSO to arrive GVA/SDP

Private Part

It is divided into two parts; Organised and Un-Organised
Organised Part

The value added estimates of Central Undertakings is provided by the CSO.

Un Organised Part

The Base Year estimates of private un-organised sector of Trade, Hotels and Restaurants have been prepared as a product of GVA per worker and work force. For trade sector, the value added per worker is obtained from the Surveys conducted by NSSO, Government of India and is moved to current year with the help of state CPI UNME. CSO is constructing Urban-Manual Index which is utilised for urban areas in the State. Consumer Price Index Numbers of Agricultural Labour of State part is used for rural areas and presently WF, GR, VAPW in these parts are provided by the CSO to arrive GVA/SDP.

B. HOTELS AND RESTAURANTS

This Sector is divided into two parts viz Public Part and Private Part

Public Part

It is then divided into two parts Central and State

Central Part

The value added estimates of Central Undertakings is provided by the CSO.

State Part

Presently the value added estimates i.e. WF, GR, VAPW of State Undertakings is provided by the C.S.O.

Private Part

It is again divided into two, Organised and Un Organised

Organised Part

Presently the value added estimates i.e. WF, GR, VAPW of State Undertakings is provided by the C.S.O

Un- Organised Part

For the Base Year the estimates from private unorganised sector of trade, hotels and restaurants have been prepared separately.

For subsequent years, the clubbed estimates of trade, hotels and restaurants from private unorganised sector have been moved with the help of Index of Gross Trading Income (GTI) of commodity producing sectors.

SUPRA REGIONAL SECTORS

In the estimates of SDP certain activities transcend state boundaries, and thus their economic contribution cannot be assigned to any one state. Such activities viz Railways, Communications, Banking and Insurance are called Supra-Regional Sectors. The estimation of GVA on these sectors is based on the allocation method using some proxy indicators supplied by the CSO both at current and constant prices and is provided to state. GVA is estimated under these sectors by following Income approach.

A. RAILWAYS

The factor income, viz., Compensation of employees, interest and profit (including depreciation) at the National level are distributed among the zonal railways, in proportion to

- (i) Total cost of staff excluding the cost of staff engaged in railway manufacturing and construction.
- (ii) Capital at charge
- (iii) Net Earnings respectively

Compensation of employees of Railway Board and Zonal Headquarters is allocated separately to the respective states on the basis of their location. Since the railway zones do not coincide with the state boundaries, a further allocation of zonal estimates becomes necessary. The value added for each zonal railway is divided into two parts, namely, value added from passenger traffic and value added from goods traffic on the basis of zone wise data on passenger and goods earnings respectively (available in the annual statistical statements of the Indian Railways). These estimates of value added from passenger traffic/goods traffic in each zone are then re-allocated among the states falling within each zone on the basis of information on vehicle kilometer per route per day or net tonne kilometer per route per day (available from railway board).

B. COMMUNICATIONS

The estimates are prepared on the basis of detailed data collected from Accountant General, Posts and Telegraphs and Telecommunications.

For post and telegraphs the all India estimates of compensation of employees are distributed among postal circles on the basis of disbursement of wages and salaries of P&T staff. The interest is allocated in proportion to the circle-wise cumulative capital expenditure. The circle-wise total revenue receipts net of expenditure is used as an indicator to allocate the Gross Profit. Rent is allocated in proportion to state wise total number of Post offices. Generally, the postal circles are co-terminus with the state boundaries. In those cases where the circle covers more than one state, allocation to the states is done on the basis of the number of workers within each state.

C. BANKING AND INSURANCE

The all India estimates of compensation of employees are allocated to states on the basis of state wise data on distribution of employees in respect of commercial banks UTI, Co-operative Societies and the Life Insurance Corporation. The state wise allocation of operating surplus of these activities is done on the basis of data obtained from concerned agencies on relevant indicators, viz., Loans and advances (Commercial Banks and Industrial Finance Corporation of India) net premium income and sum assured (LIC) deposits (Banking Department of RBI) financial disbursements (UTI), investments and profits (Cooperative Credit Societies). For other activities covered under this industry, state wise estimates are obtained by allocating the net value added by related indicators.

In these sectors the GVA/SDP are provided by CSO as a whole

REAL ESTATE, OWNERSHIP OF DWELLINGS, BUSINESS SERVICES AND LEGAL SERVICES

A. REAL ESTATE

The methodology followed in this sector is based on Income Approach. The estimates of these services are prepared using NSSO workforce and value added per worker of Enterprise Survey for the base year. For next years, the estimates of workforce are prepared using the inter survey growth rate of quinquennial employment and unemployment surveys of NSSO and value added per worker moved to subsequent years using the Index of CPI-AL for rural sector and CPI UNME for urban sector. CSO Provides WF, GR & VAPW to arrive GVA/SDP

B. OWNERSHIP OF DWELLINGS

For ownership of dwellings; the methodology consists of estimating the gross rental of residential census houses (including owner occupied) and deducting there from the cost of repairs and maintenance to obtain the SDP estimates. The estimates for the

ownership of dwellings are equivalent to the gross rental of the residential census houses less the cost of repairs and maintenance. The gross rental for the Base Year has been obtained using number of residential houses for the year 1999-00 and rent per household of NSSO for rural and urban areas in the Base Year. For subsequent years, the estimates of rural and urban residential census houses for each have been prepared by applying the geometric growth rate of two consecutive population census residential houses. The rent per household of Base Year has been moved to subsequent years with the help of CPI UNME of house rent sub group in case of urban areas. CSO Provides WF, GR & VAPW to arrive GVA/SDP

C. BUSINESS SERVICES

For estimation of other business services NSSO estimates of workforce and value added per worker as obtained from enterprise survey are used. Workforce for subsequent years are estimated basing on inter survey exponential rate of employment and unemployment surveys. CSO Provides WF, GR & VAPW to arrive GVA/SDP

D. LEGAL SERVICES

The estimates of these services have been prepared using NSSO workforce and value added per worker of Enterprise Survey. For subsequent years, the estimates of workforce have been prepared using the inter survey exponential growth rate of quinquennial employment and unemployment surveys of NSSO and value added per worker have been moved to subsequent years using the Index of Agricultural Laborer for rural sector and CPI UNME for urban sector. CSO Provides WF, GR & VAPW to arrive GVA/SDP

PUBLIC ADMINISTRATION

Estimates of GVA are prepared by using the Income Approach", as the compensation of employees being the only factor income. The

economic analysis of the budgets of State and local authorities provides the estimates for Administrative Departments from which the public administration estimates are derived by making use of Government expenditure under various purpose categories. State wise estimates of Net State Domestic Product (NSDP) from Central Government is prepared by distributing the national level estimates in preparation of number of Central Government employees in the State as on 1st October (mid-year) obtained from the Director General of Employment & Training (DGE&T). These estimates are furnished by CSO.

OTHER SERVICES

The components in this sector are Accounting and Book-keeping, Coaching Centers, Education (Excluding Coaching Centre), Renting of Machinery & Equipment without Operator, Personal / Household goods Computer and Related Activities, Tailoring Services, Funeral and Related Activities, Medical & Health Services, Human health, Veterinary Activities, Recreational, Cultural and Sporting Activities, Washing and Cleaning of Textile and Fur Products, Sanitary Services, Hair Dressing and Beauty Treatment. The gross value added of this sector is estimated by following the income approach.

I Educational Services

A. Recognized institutions

State-wise value added in respect of recognised educational institutions is estimated by taking the expenditure on salaries and wages of teaching and non-teaching staff. And these are analyzed from the Budget documents

B. Un-recognised Institutions

The All India Estimates of unrecognised institutions have been obtained as a product of value added per worker and corresponding work force from Enterprise Survey. These All India Estimates of unrecognised institutions have been allocated among the States/Union Territories.

C. Research and Scientific Services

GVA per worker in respect of Research and Scientific Services is supplied by CSO and work force is supplied by Director General of Employment and Training to arrive GVA under this sector

D. Medical and Health including Veterinary Services

The estimates have been prepared separately for public, private organised and private unorganised sectors in the New Series with Base 1999-00.

Public Sector:

The estimates of public part of Medical and Health including Veterinary Services is the sum of budget expenditure on salaries and wages of Doctors and other Medical Staff plus consumption of fixed capital culled out from the state budget documents.

Private Organised Sector

The estimates of Private Sector Organised have been obtained by using private work force of private organised taken from DGE&T and Value Added per worker of public sector of Medical and Health including Veterinary Services on year to year basis. CSO provides these and hence by GVA/SDP are arrived

Private Un-organised Sector

The estimates of workforce have been worked out after subtracting the public sector workforce of Medical and Health including Veterinary Services and workforce of private organised sector from the total workforce of Medical and Health including Veterinary Services.

Workforce thus arrived is multiplied with the value added per worker supplied by CSO the estimates of SDP for private unorganised segments. The SDP estimates for entire activity in Medical and Health including Veterinary Services are the sum of public, private organised and private unorganised sectors. For subsequent years, the estimates of workforce have been prepared using the inter survey exponential growth rate of latest two quinquennial employment and unemployment surveys of NSSO and value added per worker of rural and urban sectors have been projected to subsequent years with CPIAL and CPI UNME respectively.

II Sanitary Service

The estimates of these services have been prepared separately for public and private sectors.

Public Sector

The estimates of public part of these services are the sum of budget expenditure on salaries and wages of workers plus consumption of fixed capital.

Private Sector

The estimates have been prepared by using NSSO workforce and average compensation of Municipal workers engaged in sanitary services. For subsequent years, the workforce have been projected using the growth observed in employment of Municipal workers of sanitary services and value added per worker for rural and urban areas have been projected using the growth observed in the compensation of employees separately for rural and urban areas.

III Recreation and Entertainment Services

Estimate of this sector is prepared using workforce and value added per worker from Enterprise Survey separately for rural and urban areas which are supplied by CSO

Value added per worker is moved to subsequent years using the Consumer Price Index for Agriculture Labour for rural sector and Consumer Price Index for Urban Non-manual Employees for urban sector.

IV Rest of the Services excluding Tailoring Services

The estimates of these services have been prepared using NSSO workforce and value added per worker of Enterprise Survey separately for rural and urban areas. For subsequent years, the estimates of workforce have been prepared using the inter survey growth rate of latest two quinquennial employment and unemployment surveys as of NSSO and value added per worker have been moved to subsequent years using the CPIAL for rural sector and CPI UNME for urban sector.

V Tailoring Services

The estimates of these services are prepared using NSSO workforce and value added per worker from unorganised manufacturing survey results. These are provided by CSO to State. For subsequent years, the estimates of workforce have been prepared using the inter survey growth rate of latest two quinquennial employment and unemployment surveys of NSSO and value added per worker of rural and urban sectors have been projected to subsequent years with the Index of CPIAL and CPI UNME respectively.

In these sub sectors Work Force, Growth Rate, Value Added per Worker are supplied by CSO

LINKED SERIES

It is linking of data on the old base to the data on new base. Until the estimates are at the same base they cannot be compared. For that the back series are linked with new series and gets a long series data for planning purpose. Linking of SDP estimates are done at current and constant prices.

For the compilation of linked series two concepts are there, they are splicing method and reworking the estimates as per the current series methodology, at the component or detailed item level. The CSO adopted the method of splicing. The data and chart can be seen in page 25 onwards



TERMS USED IN STATE INCOME

Assets	Assets are entities that must be owned by some unit, or units, and from which economic benefits are derived by their owner(s) by holding or using them over a period of time.
Base period	The period that provides the weights for an index is described as the base period.
Basic price	The basic price is the amount receivable by the producer from the purchaser for a unit of a good or service produced as output minus any tax payable, and plus any subsidy receivable, on that unit as a consequence of its production or sale; it excludes any transport charges invoiced separately by the producer.
Capital stock - gross	Gross capital stock is the value of all fixed assets still in use at the end of an accounting period, at the actual or estimated current purchasers' prices for new assets of the same type, irrespective of the age of the assets.
Capital stock - net	The sum of the written-down values of all the fixed assets still in use at the end of an accounting period is described as the net capital stock.
Changes in inventories (including work-in-progress)	Changes in inventories (including work-in-progress) are measured by the value of the entries into inventories less the value of withdrawals and the value of any recurrent losses of goods held in inventories.
Classification of individual consumption by purpose (COICOP)	The classification of individual consumption by purpose (COICOP) is a classification used to identify the objectives of both individual consumption expenditure and actual individual consumption.
Classification of the functions of government (COFOG)	The classification of the functions of government (COFOG) is a classification used to identify the socio-economic objectives of current transactions, capital outlays and acquisition of financial assets by general government and its sub-sectors.
Compensation of employees	Compensation of employees is the total remuneration, in cash or in kind, payable by enterprises to employees in return for work done by the latter during the accounting period.
Computer software	Computer software consists of computer programs, program descriptions and supporting materials for both systems and applications software.

Constant prices	Constant prices are obtained by directly factoring changes over time in the values of flows of goods and services into two components reflecting changes in the prices of the goods and services concerned and changes in their volumes (i.e. changes in "constant price terms").
Consumption	Consumption is an activity in which institutional units use up goods or services; consumption can be either intermediate or final.
Consumption of fixed capital	Consumption of fixed capital represents the reduction in the value of the fixed assets used in production during the accounting period resulting from physical deterioration, normal obsolescence or normal accidental damage.
Cultivated assets	Cultivated assets are livestock for breeding (including fish and poultry), dairy, draught, etc. and vineyards, orchards and other plantations of trees yielding repeat products that are under the direct control, responsibility and management of institutional units.
Defined benefit pension plans	Defined benefit pension plans are those in which the level of pension benefits promised to participating employees is guaranteed; benefits are related by some formula to participants' length of service and salary and are not totally dependent on either the participants' contributions or the assets in the fund.
Depletion of natural economic assets	The depletion of natural economic assets is the reduction in the value of deposits of subsoil assets, natural forests, fish stocks in the open seas and other non-cultivated biological resources as a result of the physical removal and using up of the assets.
Depreciation	Depreciation as usually calculated in business accounts is a method of allocating the costs of past expenditures on fixed assets over subsequent accounting periods; note that the depreciation methods favored in business accounting and those prescribed by tax authorities almost invariably deviate from the concept of consumption of fixed capital employed in the SNA and so the term "consumption of fixed capital" is used in the SNA to distinguish it from "depreciation" as typically measured in business accounts.

Disposable income	Disposable income is derived from the balance of primary incomes of an institutional unit or sector by adding all current transfers, except social transfers in kind, receivable by that unit or sector and subtracting all current transfers, except social transfers in kind, payable by that unit or sector.
Disposals	Disposals of assets (inventories, fixed assets or land or other non-produced assets) by institutional units occur when one of those units sells any of the assets to another institutional unit.
Domestic output	Domestic output is output produced by resident enterprises.
Double deflation	Double deflation is a method whereby gross value added is measured at constant prices by subtracting intermediate consumption at constant prices from output at constant prices; this method is feasible only for constant price estimates which are additive, such as those calculated using a Laspeyres' formula (either fixed-base or for estimates expressed in the previous year's prices).
Durable good	A durable good is one which may be used repeatedly or continuously over a period of more than a year, assuming a normal or average rate of physical usage.
Dwellings	Dwellings are buildings that are used entirely or primarily as residences, including any associated structures, such as garages, and all permanent fixtures customarily installed in residences; movable structures, such as caravans, used as principal residences of households are included.
Entertainment, literary or artistic originals	Entertainment, literary or artistic originals are the original films, sound recordings, manuscripts, tapes, models, etc, on which drama performances, radio and television programming, musical performances, sporting events, literary and artistic output, etc, are recorded or embodied.
Establishment	An establishment is an enterprise, or part of an enterprise, that is situated in a single location and in which only a single (non-ancillary) productive activity is carried out or in which the principal productive activity accounts for most of the value added.
Expenditures	Expenditures are the values of the amounts that buyers pay, or agree to pay, to sellers in exchange for goods or services that sellers provide to them or to other institutional units designated by the buyers.

Exports of goods	Exports of goods consist of exports of the following items from residents to non-residents, generally with a change of ownership being involved: general merchandise, goods for processing, goods procured in domestic ports by non-resident carriers, and non-monetary gold.
Exports of services	Exports of services consist of the following services provided by residents to non-residents: transportation; travel; communications; construction; insurance; financial; computer and information; royalties and licence fees; other business services; personal, cultural, and recreational services; and government services n.i.e.
Factor cost	Gross value added at factor cost is not a concept used explicitly in the System but it can easily be derived by subtracting the value of any taxes, less subsidies, on production payable out of gross value added.
Final consumption	Final consumption consists of goods and services used up by individual households or the community to satisfy their individual or collective needs or wants.
Final consumption expenditure of government	Government final consumption expenditure consists of expenditure, including imputed expenditure, incurred by general government on both individual consumption goods and services and collective consumption services.
Final consumption expenditure of households	Household final consumption expenditure consists of the expenditure, including imputed expenditure, incurred by resident households on individual consumption goods and services, including those sold at prices that are not economically significant.
Final consumption expenditure of NPISHs	Final consumption expenditure of NPISHs consists of the expenditure, including imputed expenditure, incurred by resident NPISHs on individual consumption goods and services.
Financial auxiliaries	The financial auxiliaries sub-sector consists of all resident corporations and quasi-corporations engaged primarily in activities closely related to financial intermediation but which do not themselves perform an intermediation role.
Financial corporations	The financial corporations sector consists of all resident corporations or quasi-corporations principally engaged in financial intermediation or in auxiliary financial activities which are closely related to financial intermediation.

Financial enterprises	Financial enterprises are enterprises that are principally engaged in financial intermediation or in auxiliary financial activities which are closely related to financial intermediation.
Financial intermediaries	Financial intermediaries are units which incur liabilities on their own account on financial markets by borrowing funds which they lend on different terms and conditions to other institutional units.
Financial intermediation	Financial intermediation is a productive activity in which an institutional unit incurs liabilities on its own account for the purpose of acquiring financial assets by engaging in financial transactions on the market.
Financial intermediation services indirectly measured (FISIM)	Financial intermediation services indirectly measured (FISIM) is an indirect measure of the value of financial intermediation services provided but for which financial institutions do not charge explicitly.
Fixed assets	Fixed assets are tangible or intangible assets produced as outputs from processes of production that are themselves used repeatedly or continuously in other processes of production for more than one year.
Foreign direct investment	Foreign direct investment is the category of international investment that reflects the objective of a resident entity in one economy to obtain a lasting interest in an enterprise resident in another economy; foreign direct investment is defined as ownership of 10 per cent or more of the ordinary shares or voting power (for an incorporated enterprise) or the equivalent (for an unincorporated enterprise).
Functional classifications	Functional classifications provide a means of classifying, by purpose or socio-economic objective, certain transactions of producers and of three institutional sectors - namely households, general government and non-profit institutions serving households (NPISH)s.
GDP - expenditure based	Expenditure-based GDP is total final expenditures at purchasers' prices (including the f.o.b. value of exports of goods and services), less the f.o.b. value of imports of goods and services.
GDP - income based	Income-based GDP is compensation of employees, plus taxes less subsidies on production and imports, plus gross mixed income, plus gross operating surplus.

GDP - output based	Output-based GDP is the sum of the gross values added of all resident producers at producers' prices, plus taxes less subsides on imports, plus all non-deductible VAT (or similar taxes).
GDP at market prices	GDP at market prices is the sum of the gross values added of all resident producers at producers' prices, plus taxes less subsides on imports, plus all non-deductible VAT (or similar taxes).
GNI (gross national income)	GNI (gross national income) is GDP less net taxes on production and imports, less compensation of employees less property income payable to the rest of the world plus the corresponding items receivable from the rest of the world (in other words, GDP less primary incomes payable to non-resident units plus primary incomes receivable from non-resident units); an alternative approach to measuring GNI at market prices is as the aggregate value of the balances of gross primary incomes for all sectors; (note that GNI is identical to gross national product (GNP) as previously used in national accounts generally).
Goods	Goods are physical objects for which a demand exists, over which ownership rights can be established and whose ownership can be transferred from one institutional unit to another by engaging in transactions on markets.
Goods and services account	The goods and services account shows for the economy as a whole and for groups of products, the total resources in terms of output and imports, and the uses of goods and services in terms of intermediate consumption, final consumption, gross capital formation and exports.
Government final consumption expenditure	Government final consumption expenditure consists of expenditure, including imputed expenditure, incurred by general government on both individual consumption goods and services and collective consumption services.
Gross	The term "gross" is a common means of referring to values before deducting consumption of fixed capital (generally used as in "gross capital stock" or "gross domestic product").
Gross capital formation	Gross capital formation is measured by the total value of the gross fixed capital formation, changes in inventories and acquisitions less disposals of valuables for a unit or sector.

Gross fixed capital formation	Gross fixed capital formation is measured by the total value of a producer's acquisitions, less disposals, of fixed assets during the accounting period plus certain additions to the value of non-produced assets (such as subsoil assets or major improvements in the quantity, quality or productivity of land) realised by the productive activity of institutional units.
Gross national disposable income	Gross national disposable income may be derived from gross national income by adding all current transfers in cash or in kind receivable by resident institutional units from non-resident units and subtracting all current transfers in cash or in kind payable by resident institutional units to non-resident units.
Gross national income (GNI)	Gross national income (GNI) is GDP less net taxes on production and imports, less compensation of employees less property income payable to the rest of the world plus the corresponding items receivable from the rest of the world (in other words, GDP less primary incomes payable to non-resident units plus primary incomes receivable from non-resident units); an alternative approach to measuring GNI at market prices is as the aggregate value of the balances of gross primary incomes for all sectors; (note that gross national income is identical to gross national product (GNP) as previously used in national accounts generally).
Gross saving	Gross saving is gross disposable income less final consumption expenditure.
Gross value added	Gross value added is the value of output less the value of intermediate consumption; it is a measure of the contribution to GDP made by an individual producer, industry or sector.
Gross value added at basic prices	Gross value added at basic prices is output valued at basic prices less intermediate consumption valued at purchasers' prices.
Gross value added at producers' prices	Gross value added at producers' prices is output valued at producers' prices less intermediate consumption valued at purchasers' prices.
Historic cost accounting	Historic cost accounting is a valuation method which requires goods or assets used in production to be valued by the expenditures actually incurred to acquire those goods or assets, however far back in the past those expenditures took place.

Holding gains	Positive or negative holding gains may accrue during the accounting period to the owners of financial and non-financial assets and liabilities as a result of a change in their prices (holding gains are sometimes referred to as "capital gains").
Household final consumption expenditure	Household final consumption expenditure consists of the expenditure, including imputed expenditure, incurred by resident households on individual consumption goods and services, including those sold at prices that are not economically significant.
Illegal production	Illegal production is the production of goods or services whose sale, distribution or possession is forbidden by law; and production activities which are usually legal but which become illegal when carried out by unauthorised producers; the scope of illegal production varies depending on the laws in place in individual countries (eg, prostitution is legal in some countries but illegal in others).
Income	Income is the maximum amount that a household, or other unit, can consume without reducing its real net worth.
Income from abroad - net	Net income from abroad is the difference between the total values of the primary incomes receivable from, and payable to, non-residents.
Industry	An industry consists of a group of establishments engaged on the same, or similar, kinds of production activity; the classification of productive activities used in the System is ISIC (Rev.3).
Institutional sectors	Institutional units are grouped together to form institutional sectors, on the basis of their principal functions, behaviour, and objectives.
Institutional unit	An institutional unit is an economic entity that is capable, in its own right, of owning assets, incurring liabilities and engaging in economic activities and in transactions with other entities.
Insurance	The activity of insurance is intended to provide individual institutional units exposed to certain risks with financial protection against the consequences of the occurrence of specified events; it is also a form of financial intermediation in which funds are collected from policyholders and invested in financial or other assets which are held as technical reserves to meet future claims arising from the occurrence of the events specified in the insurance policies.

Insurance corporations	Insurance corporations consist of incorporated, mutual and other entities whose principal function is to provide life, accident, sickness, fire or other forms of insurance to individual institutional units or groups of units.
Insurance technical reserves	The technical reserves held by insurance enterprises consist of the actuarial reserves against outstanding risks in respect of life insurance policies, including reserves for with-profit policies which add to the value on maturity of with-profit endowments or similar policies, prepayments of premiums and reserves against outstanding claims.
Intangible fixed assets	Intangible fixed assets are non-financial produced fixed assets that mainly consist of mineral exploration, computer software, entertainment, literary or artistic originals intended to be used for more than one year.
Intangible non-produced assets	Intangible non-produced assets are assets that entitle their owners to engage in certain specific activities or to produce certain specific goods or services and to exclude other institutional units from doing so except with the permission of the owner (eg, patented entities or purchased goodwill).
Integrated economic accounts	The integrated economic accounts comprise the full set of accounts of institutional sectors and the rest of the world, together with the accounts for transactions (and other flows) and the accounts for assets and liabilities.
Interest	Interest is the amount that the debtor becomes liable to pay to the creditor over a given period of time without reducing the amount of principal outstanding, under the terms of the financial instrument agreed between them.
Intermediate consumption	Intermediate consumption consists of the value of the goods and services consumed as inputs by a process of production, excluding fixed assets whose consumption is recorded as consumption of fixed capital; the goods or services may be either transformed or used up by the production process.
Inventories	Inventories consist of stocks of outputs that are still held by the units that produced them prior to their being further processed, sold, delivered to other units or used in other ways and stocks of products acquired from other units that are intended to be used for intermediate consumption or for resale without further processing.

Inventories - changes in (including work-in-progress)	Changes in inventories (including work-in-progress) are measured by the value of the entries into inventories less the value of withdrawals and the value of any recurrent losses of goods held in inventories.
Inventories of work-in-progress on cultivated assets	Inventories of work-in-progress on cultivated assets consist of livestock raised for products yielded only on slaughter, such as fowl and fish raised commercially, trees and other vegetation yielding once-only products on destruction and immature cultivated assets yielding repeat products.
ISIC	ISIC is the United Nations International Standard Industrial Classification of All Economic Activities; the third revision of ISIC is used in the 1993 SNA.
Kind-of-activity unit	A kind-of-activity unit is an enterprise, or a part of an enterprise, which engages in only one kind of (non-ancillary) productive activity or in which the principal productive activity accounts for most of the value added.
Land	Land is the ground, including the soil covering and any associated surface waters, over which ownership rights are enforced.
Machinery and equipment (assets)	Machinery and equipment (assets) consist of transport equipment and other machinery and equipment other than that acquired by households for final consumption.
Maintenance and repairs (of fixed assets)	Ordinary maintenance and repairs of fixed assets are activities that owners or users of fixed assets are obliged to undertake periodically in order to be able to utilise assets over their expected service lives (they are current costs that cannot be avoided if the fixed assets are to continue to be used); maintenance and repairs do not change the fixed asset or its performance, but simply maintain it in good working order or restore it to its previous condition in the event of a breakdown (note the contrast between this item and "major renovations or enlargements").
Major renovations or enlargements (of fixed assets)	Major renovations or enlargements of fixed assets are activities which increase the performance or capacity of existing fixed assets or significantly extend their previously expected service lives; the decision to renovate, reconstruct or enlarge a fixed asset is a deliberate investment decision which may be undertaken at any time and is not dictated by the condition of the asset (note the contrast between this item and "maintenance and repairs").

Margin (trade)	A trade margin is the difference between the actual or imputed price realised on a good purchased for resale (either wholesale or retail) and the price that would have to be paid by the distributor to replace the good at the time it is sold or otherwise disposed of.
Margin (transport)	A transport margin consists of those transport charges paid separately by the purchaser in taking delivery of the goods at the required time and place.
Market output	Market output is output that is sold at prices that are economically significant or otherwise disposed of on the market, or intended for sale or disposal on the market.
Market prices	Market prices for transactions are the amounts of money willing buyers pay to acquire something from willing sellers.
Mineral exploration	Mineral exploration consists of the value of expenditures on exploration for petroleum and natural gas and for non-petroleum deposits.
Mixed income	Mixed income is the surplus or deficit accruing from production by unincorporated enterprises owned by households; it implicitly contains an element of remuneration for work done by the owner, or other members of the household, that cannot be separately identified from the return to the owner as entrepreneur but it excludes the operating surplus coming from owner-occupied dwellings.
Monetary gold	Monetary gold is gold owned by the monetary authorities or others subject to their effective control that is held as a financial asset and as a component of foreign reserves.
National income	National income is the total value of the primary incomes receivable within an economy less the total of the primary incomes payable by resident units.
Net	The term "net" is a common means of referring to values after deducting consumption of fixed capital (generally used as in "net capital stock" or "net domestic product"); it should be noted, however, that the term "net" can be used in different contexts in the national accounts, such as "net income from abroad" which is the difference between two income flows.
Net domestic product (NDP)	Net domestic product (NDP) is obtained by deducting the consumption of fixed capital from gross domestic product.

Net fixed capital formation.	Net fixed capital formation consists of gross fixed capital formation less consumption of fixed capital.
Net income from abroad	The difference between the total values of the primary incomes receivable from, and payable to, non-residents is often described as net income from abroad.
Net national income	The aggregate value of the balances of net primary incomes summed over all sectors is described as net national income.
Net saving	Net saving is net disposable income less final consumption expenditure.
Net value added	Net value added is the value of output less the values of both intermediate consumption and consumption of fixed capital.
Net worth	Net worth is the value of all the non-financial and financial assets owned by an institutional unit or sector less the value of all its outstanding liabilities; it is a measure of the wealth of a unit or sector at a point in time.
Non-financial assets	Non-financial assets are entities, over which ownership rights are enforced by institutional units, individually or collectively, and from which economic benefits may be derived by their owners by holding them, or using them over a period of time, that consist of tangible assets, both produced and non-produced, and most intangible assets for which no corresponding liabilities are recorded.
Non-financial corporations	Non-financial corporations are corporations whose principal activity is the production of market goods or non-financial services.
Non-financial quasi-corporations	Non-financial quasi-corporations are quasi-corporations whose principal activity is the production of market goods or non-financial services.
Non-life insurance premiums	Non-life insurance premiums comprise both the actual premiums payable by policyholders to obtain insurance cover during the accounting period (premiums earned) and the premium supplements payable out of the property income attributed to insurance policyholders, but excluding social contributions.
Non-market producers	Non-market producers are producers that provide most of their output to others free or at prices which are not economically significant.

Non-profit institutions (NPIs)	Non-profit institutions (NPIs) are legal or social entities created for the purpose of producing goods and services whose status does not permit them to be a source of income, profit or other financial gain for the units that establish, control or finance them.
Non-profit institutions controlled and mainly financed by government	Non-profit institutions controlled and mainly financed by government are properly constituted legal entities which exist separately from government but which are financed mainly by government and over which government exercises control.
Non-profit institutions engaged in market production	Non-profit institutions engaged in market production consist of those NPIs which charge fees determined by their costs of production and which are sufficiently high to have a significant influence on the demand for their services, but any surpluses such institutions make must be retained within those institutions as their status as "Non-profit institutions (NPIs)" prevents them from distributing them to others
Non-profit institutions engaged in non-market production	Non-profit institutions engaged in non-market production are NPIs that are incapable of providing financial gain to the units which control or manage them, and which must rely principally on funds other than receipts from sales to cover their costs of production or other activities.
Non-profit institutions serving households (NPISHs)	Non-profit institutions serving households (NPISHs) consist of NPIs which are not financed and controlled by government and which provide goods or services to households free or at prices that are not economically significant.
Non-residential buildings	Non-residential buildings are buildings other than dwellings, including fixtures, facilities and equipment that are integral parts of the structures and costs of site clearance and preparation.
Operating surplus	The operating surplus measures the surplus or deficit accruing from production before taking account of any interest, rent or similar charges payable on financial or tangible non-produced assets borrowed or rented by the enterprise, or any interest, rent or similar receipts receivable on financial or tangible non-produced assets owned by the enterprise; (note: for unincorporated enterprises owned by households, this component is called "mixed income").

Output	Output consists of those goods or services that are produced within an establishment that become available for use outside that establishment, plus any goods and services produced for own final use.
Perpetual inventory method (PIM)	The perpetual inventory method (PIM) is a method of constructing estimates of capital stock and consumption of fixed capital from time series of gross fixed capital formation; it allows an estimate to be made of the stock of fixed assets in existence and in the hands of producers which is generally based on estimating how many of the fixed assets installed as a result of gross fixed capital formation undertaken in previous years have survived to the current period.
PPP (purchasing power parity)	A PPP (purchasing power parity) is a price relative which measures the number of units of country B's currency that are needed in country B to purchase the same quantity of an individual good or service as 1 unit of country A's currency will purchase in country A.
Primary incomes	Primary incomes are incomes that accrue to institutional units as a consequence of their involvement in processes of production or ownership of assets that may be needed for purposes of production.
Produced assets	Produced assets are non-financial assets that have come into existence as outputs from processes that fall within the production boundary of the SNA.
Producer's price	The producer's price is the amount receivable by the producer from the purchaser for a unit of a good or service produced as output minus any VAT, or similar deductible tax, invoiced to the purchaser; it excludes any transport charges invoiced separately by the producer.
Production	Production is an activity, carried out under the responsibility, control and management of an institutional unit, that uses inputs of labour, capital and goods and services to produce outputs of other goods and services.
Production account	The production account records the activity of producing goods and services as defined within the SNA; its balancing item, gross value added, is a measure of the contribution to GDP made by an individual producer, industry or sector.

Production boundary	The production boundary includes all production actually destined for the market, whether for sale or barter, all goods or services provided free to individual households or collectively to the community by government units or NPISHs, all goods produced for own final use, own-account production of housing services by owner occupiers and services produced by employing paid domestic staff.
Property income	Property income is the income receivable by the owner of a financial asset or a tangible non-produced asset in return for providing funds to or putting the tangible non-produced asset at the disposal of, another institutional unit; it consists of interest, the distributed income of corporations (ie, dividends and withdrawals from income of quasi-corporations), reinvested earnings on direct foreign investment, property income attributed to insurance policy holders, and rent.
Property income attributed to insurance policyholders	The property income attributed to insurance policyholders is the investment income receivable by insurance enterprises on insurance technical reserves; it is shown in the accounts as being paid by the insurance enterprises to the insurance policyholders because the technical reserves are assets of the policyholders.
Purchaser's price	The purchaser's price is the amount paid by the purchaser, excluding any deductible VAT or similar deductible tax, in order to take delivery of a unit of a good or service at the time and place required by the purchaser; the purchaser's price of a good includes any transport charges paid separately by the purchaser to take delivery at the required time and place.
Quasi-corporations	Quasi-corporations are unincorporated enterprises that function as if they were corporations, and which have complete sets of accounts, including balance sheets.
Reference rate (of interest)	The reference rate (of interest) is the pure cost of borrowing funds (i.e. a rate from which the risk premium has been eliminated to the greatest extent possible and which does not include any intermediation services).
Reinvested earnings on direct foreign investment	Reinvested earnings on direct foreign investment consist of the retained earnings of a direct foreign investment enterprise and which are treated as if they were distributed and remitted to foreign direct investors in proportion to their ownership of the equity of the enterprise and then reinvested by them in the enterprise.

Rent	Rent is the sum of rents on land and rents on subsoil assets.
Research and development	Research and development by a market producer is an activity undertaken for the purpose of discovering or developing new products, including improved versions or qualities of existing products, or discovering or developing new or more efficient processes of production.
SAM (social accounting matrix)	A SAM (social accounting matrix) is a means of presenting the SNA accounts in a matrix which elaborates the linkages between a supply and use table and institutional sector accounts; a typical focus of a SAM on the role of people in the economy may be reflected by, among other things, extra breakdowns of the household sector and a disaggregated representation of labour markets (i.e., distinguishing various categories of employed persons).
Satellite accounts	Satellite accounts provide a framework linked to the central accounts and which enables attention to be focussed on a certain field or aspect of economic and social life in the context of national accounts; common examples are satellite accounts for the environment, or tourism, or unpaid household work.
Saving	Saving is disposable income less final consumption expenditure (or adjusted disposable income less actual final consumption, after taking account of an adjustment for pension funds); saving is an important aggregate which can be calculated for each institutional sector.
Services	Services are outputs produced to order and typically consist of changes in the conditions of the consuming units realised by the activities of producers at the demand of the consumers; by the time their production is completed they must have been provided to the consumers.
Single indicator method of deflation	A single indicator method of deflation is a means of estimating the volume movements of value added directly using only one time series instead of double deflation.
SNA (System of National Accounts)	The System of National Accounts (SNA) consists of a coherent, consistent and integrated set of macroeconomic accounts, balance sheets and tables based on a set of internationally agreed concepts, definitions, classifications and accounting rules.

Stocks	Stocks are a position in, or holdings of, assets and liabilities at a point in time and the System records stocks in accounts, usually referred to as balance sheets, and tables at the beginning and end of the accounting period; stocks result from the accumulation of prior transactions and other flows, and they are changed by transactions and other flows in the period (note that stocks of goods are referred to as "inventories" in the System).
Straight-line depreciation	Straight-line depreciation is a depreciation profile based on a constant annual amount of capital consumption over the life of the asset.
Subsidies	Subsidies are current unrequited payments that government units, including non-resident government units, make to enterprises on the basis of the levels of their production activities or the quantities or values of the goods or services which they produce, sell or import.
Subsidies on losses of government trading organisations	Subsidies on losses of government trading organisations consist of the losses incurred by government trading organisations whose function is to buy and sell the products of resident enterprises; when such organisations incur losses as a matter of deliberate government economic or social policy by selling at lower prices than those at which they purchased the goods, the difference between the purchase and the selling prices should be treated as a subsidy.
Tangible fixed assets	Tangible fixed assets are non-financial produced assets that consist of dwellings; other buildings and structures; machinery and equipment and cultivated assets.
Tangible non-produced assets	Tangible non-produced assets are natural assets - land, subsoil assets, non-cultivated biological resources and water resources - over which ownership may be established and transferred
Total economy	The total economy consists of all the institutional units which are resident in the economic territory of a country.
Trade margin	A trade margin is the difference between the actual or imputed price realised on a good purchased for resale (either wholesale or retail) and the price that would have to be paid by the distributor to replace the good at the time it is sold or otherwise disposed of.

Unit value index	A unit value index is a "price" index which measures the change in the average value of units that are not homogeneous and which may therefore be affected by changes in the mix of items as well as by changes in their prices.
Valuables	Valuables are produced assets that are not used primarily for production or consumption, that are expected to appreciate or at least not to decline in real value, that do not deteriorate over time under normal conditions and that are acquired and held primarily as stores of value.
Volume index	A volume index (also called a "quantity index") is most commonly presented as an average of the proportionate changes in the quantities of a specified set of goods or services between two periods of time; volume indices may also compare the relative levels of activity in different countries (eg, those calculated using PPPs).
Wages and salaries	Wages and salaries consist of the sum of wages and salaries in cash and wages and salaries in kind.
Wages and salaries in cash	Wages and salaries in cash consist of wages or salaries payable at regular weekly, monthly or other intervals, including payments by results and piecework payments; plus allowances such as those for working overtime; plus amounts paid to employees away from work for on holiday; plus ad hoc bonuses and similar payments; plus commissions, gratuities and tips received by employees.
Wages and salaries in kind	Wages and salaries in kind consist of remuneration in the form of goods and/or services that are not necessary for work and can be used by employees in their own time, and at their own discretion, for the satisfaction of their own needs or wants or those of other members of their households.
Work-in-progress - inventories	Inventories of work-in-progress consist of goods and services that are partially completed but that are not usually turned over to other units without further processing or that are not mature and whose production process will be continued in a subsequent period by the same producer.
Work-in-progress on cultivated assets - inventories	Inventories of work-in-progress on cultivated assets consist of livestock raised for products yielded only on slaughter, including fowl and fish raised commercially, trees and other vegetation yielding once-only products on destruction and immature cultivated assets yielding repeat products.
