## A REPORT ON COCONUT CULTIVATION IN KERALA

Among the cultivation of various crops in the state, Coconut occupied first place. The name of the state has some relationship with the coconut cultivation in the state. It has socio economic significance on the economy and a large number of small and marginal farmers earn their livelihood from the cultivation of this crop. In short, it is a way of life for the farming community in the state. Our state became very famous in the cultivation of coconut crops, however presently the coconut cultivation in the state is confronting many problems like wide spread pest attack (mandari), predominance of Root wilt disease and the existence of large number of palms without any production etc. In order to remove the disease affected palms, government have implemented schemes like removing root wilt affected palms, distribution of pump sets, support to digging of wells, seed nuts procurement and spraying for mite infestation have also been implemented by the government in connection with coconut cultivation. Eventhough government have initiated so many programmes in the state the area and the production of coconut in the state are not increased to an expected level.

India is the third largest coconut producing country in the world, behind Indonesia and Philippines. Among the states in India, Kerala is in the first place in coconut crop. Total area of coconut in India during 1977-78 is 1060000 Ha and the corresponding area of Kerala during the period is 670000 Ha, which is 63.21 % of the total coconut area of the country. The total production of coconut in the country during the period is 5413 million nuts and the corresponding figure of the state is 3053 million nuts ie 56.20% of the total production of the country. However the position has been changed gradually. The total coconut cultivated area in the country during 2005-06 is 1950000 Ha and the corresponding area of the state during the period is 897833 Ha and the percentage to the total area of the state is 46.04. The total production of coconut in the country during the period is 14811 million nuts and the corresponding production of coconut in the state is 6326 million nuts ie 42.71 % of the total production of the country. Comparing with national level, the area and production of coconut in the state is decreasing continuously. The area of coconut shows an increasing trend in most of the years since 1977-78. The coconut cultivated area is highest during 1999-'00 and 2000-'01. However the production in the corresponding years are 5680 & 5536 million nuts respectively.

Eventhough the state is first place in area and production of coconut in the country, the productivity of the coconut in the state is lower than the productivity of other coconut cultivated states in the country. This may be due to

1. The existence of a sizeable number of senile and unproductive palms
2. The existence of root wilt affected palms
3. Existence of high density of trees
4. Most of the small and marginal farmers are not following scientific method of coconut cultivation
5. Increase in the cost of cultivation of coconut

One of the important problems being faced by the coconut cultivators in the state is the absence of direct price support for their product. If the government initiates action like promoting coconut processing units and tender coconut parlors, it will encourage to increase both area and production of coconut in the state. Adoption of advanced technology in coconut cultivation will help to increase the productivity of the coconut.

Among the crops cultivated in the state, coconut occupies the first place followed by Rubber. An interesting fact is that a good portion of coconut cultivated area has been converted to rubber cultivation in the state due to the higher profitability in Rubber cultivation than the other crops.

Considering the area of coconut cultivation, it was highest in 2000-2001 ie 925783 Ha. Thereafter the area of coconut cultivation is decreasing in the state up to 2005-06, except for 2004-05. In the case of production of coconut it was highest in the state during 2005-06 ie, 6326 million nuts. The production of coconut in the state shows a fluctuating tendency in each year.

Comparing the yearwise productivity of coconut in the state, it is highest in 2005-06 ie 7046 nuts per Ha .The productivity of the coconut in the state is increasing regularly since 2000 –01 onwards.

With regard to the cutting and removal of diseased coconut palms in the state, the data regarding this is available from 1982-83 onwards. The data reveals that a good number of palms are cutting each year for the rejuvenation of better palms and to prevent spread of diseases to other good coconut palms.

Cost of cultivation for coconut palm is very high in the state especially the cost incurring for hired human labourers. Farmers are not willing to do various operations in coconut cultivation regularly due to the low yield in coconut palms. The yield of coconut palms is decreasing due to the affect of diseases like manderi, wind falls to the palms. The existence of

intercropping cultivation in coconut plots caused to decrease the yield of the crop to a certain extent.

In the case of farm price of coconut, the farmers are not obtaining fair price for their products. This is another important reason for decreasing the area and production of the coconut in the state. The farm price of coconut is highest in 2004 however the same was very low during 2001. If there are sufficient coconut processing units in the state, farmers will get a good fair price for their products and it will encourage the farmers for more coconut cultivation in the state.

### **Area, Production and Productivity of Coconut**


Area of coconut is estimated based on a sample survey conducted annually under the EARAS scheme Viz Area enumeration survey. The lowest stratum used in the sample survey is an Investigator zone, which is to be a part Panchayat, a full Panchayat or more than one Panchayats. There are 811 Investigator zones in the state and the sample survey is covered in the entire Investigator Zones. The data is collected through the method of quantitative estimate/enumeration of coconut palms of both bearing and non-bearing palms. In order to enumerate the area of coconut, Investigators select 100 clusters randomly from their Investigator zones in each agriculture year. Investigator collects the details of all coconut palms cultivated in the respective clusters. For the estimation of production and productivity of coconut, Investigators conduct a sample survey on General Crop Estimation survey under EARAS scheme. The yield of the coconut is estimated by conducting scientifically designed crop cutting experiments in the selected plot. Crop cutting experiments are conducted in all Investigator zones in the state and in each Investigator zones; three crop cutting experiments are conducted for the yield assessment of coconut. In each agriculture year, there are 2433 crop cutting experiments targeted for conducting crop cutting experiments of coconut in the state.



The above table shows the Gross and Net cultivated area in the state. From 1997-98 onwards the net cultivated area in the state is decreasing continuously except 2003-04 where a marginal increase therein. Percentage of coconut area to total net area of the state possessed a major portion of the area. It is obvious that around 40 % of the total net area is occupied by coconut cultivation. The area of coconut cultivation is highest during 2000-01.

(1994-'95 to 2005-'06)**




**Comparison of Coconut Area to Net Area


In 1985-86 Coconut area is highest in Kozhikode district followed by Thiruvananthapuram district. The lowest coconut area during the period is in wayanad district having area of 3565 ha. In the case of production of coconut, it is also highest in Kozhikode district during the year. But in the case of productivity of coconut it is highest in Thrissur followed by Pathanamthitta district. During 2005-06, the area of coconut is also highest in Kozhikode district followed by Malappuram district and the same is lowest in wayanad district. However the production of coconut during the period, is highest in Malappuram district followed by Kozhikode district and the lowest production of coconut is in Wayanad district. In the case of productivity of coconut, it is highest in Thrissur district during the period followed by Kozhikode and the same is lowest in wayanad district.



DISTRICTWISE COCONUT AREA IN KERALA




DISTRICTWISE COCONUT PRODUCTION IN KERALA



■ 1985-86 □ 1990-91 ■ 1995-96 □ 2000-01 □ 2005-06


DISTRICTWISE COCONUT PRODUCTIVITY IN KERALA



□ 1985-86 □ 1990-91 □ 1995-96 □ 2000-01 □ 2005-06




**% Distribution of Cost of Cultivation (Cost "A") of Coconut in Kerala**




