





## **TRICHUR DISTRICT**

The District came to be known by its present name after its headquarters town of Trichur. Trichur is the anglicised form of the vernacular name "Thrissivaperur".

The District lies between  $10^{\circ} 10'$  and  $10^{\circ}-46'$  N. Latitude and  $75^{\circ}-55'$  E. longitude. It is bounded on the north by Palghat District. Coimbatore District of Tamil Nadu State form the eastern boundary together with portions of Palghat District. Ernakulam and Kottayam Districts form the southern boundaries. The Arabian sea lies to its west.

The area of the District is 2944.72 sq. k. m. It has 51.5 kms. of unbroken coast line on the west. Behind this coastal belt occurs shallow backwaters. Numerous streams from the higher reaches empty into these lakes, which in turn are connected to the sea by the outlets at Chetwai and Cranganore.

The District is served at its Southern and Northern boundaries by the Periyar and Bharathapuzha. The other rivers of the district are: (1) Kechari or Wadakkancherry (43 km) (2) Karivannoor (48 km) and (3) Chalakudy (144 km). Sholayar and Peringalkuthu hydro-electric projects are located at the basin of Chalakudy river which springs from Anamalai in the Western ghats. The Karivannoor river has also been dammed up at Peechi, 23 km. away from Trichur town to irrigate an area of 17,550 hectares in the District. The Vazhani dam (irrigation) with a command area of 3570 hectares is located at the upper reaches of the Keecheri river.

The eastern region of the District consists of a succession of ridges and conical peaks and scattered hills of considerable elevation. The forest area is recorded as 45.13% of the area of the District. They occur in Thalappally, Mukundapuram and Trichur Taluks. Teak, ebony, irul and other valuable trees grow luxuriously in the forest area.

The three natural divisions of Kerala namely, the high land, mid land and the low land occur in this District also. The high lands are at the eastern end. The mid land extends from the high lands to the west and is bounded on the west by the low land region or coastal belt. A number of valuable trees and some plantation crops like tea, coffee and rubber grow in the high lands. Here the altitude is more than 4700 feet in the case of certain hills. Coconuts, arecanut, cashewnut and a number of other cash crops and vegetables are grown in the plains of the midlands while paddy is grown in the valleys. The coastal belt, lying between Cranganore and Chetwai, abounds in coconut plantations. This is a fertile region enriched by the silt and alluvium brought down by the rivers. The low lying areas are cultivated with rice by putting up artificial embankments where there are no natural ones.

The District is served by a few navigation canals. Important among them are the Ponnani Canal in Chowghat Taluk, the Connoli canal between Chowghat and Mukundapuram Taluks, the Shanmukham Canal also in Mukundapuram Taluk and the Puthen thodu in Trichur Taluk. These canals together with the backwaters form the main arteries of water communication.

The right and left bank canals of the Peechi, Chalakudi and Vazhani Irrigation systems are the chief irrigation canals.

The climate is tropical and humid with an oppressive hot season. The rainfall is seasonal and fairly assured.

The present Trichur District with the exception of Chowghat taluk formed part of the old Cochin State. As a result of the States Reorganisation Act, and successive changes brought out by the State administration, the present district with 5 Taluks came into existence. The following are the Taluks of the District with the area and number of villages noted against each.

The population of the District was 21.29 lakhs according to the 1971 census. The density per sq. k. m. was 702 as against the State average of 548. Among the taluks, Chowghat had the highest density of 1684 followed by Cranganore with 1541 persons per sq. k. m. Mukundapuram recorded the lowest density of 447 persons per sq. k. m. The decade variation (in percentages) large as they were for the past many decades from 1931 onwards were surpassed in the present decade (29.82).

The trend of an increasing sex ratio for the District was noted during the decades upto 1951 when it stood at 1102. During the next decade it decreased to 1090 and it has kept up this reverse trend during this decade also by registering a sex ratio of 1081. Still the sex ratio is much larger than that for the State (1016). Chowghat and Thalappally Taluks are the leading ones in this regard.

The literacy which was 48% in 1961 shot up to nearly 62% in 1971. in the District. The increase compares favourably with the figures for the State which were 47% and 60% respectively for the two decennial years. The increase in literacy is more marked among females. It increased by about 15% during the decade while male literacy percentage increased only by about 11.

There were 951 institutions for school education during 1970-71 with 424,821 students. The largest number of schools were in Trichur followed by Mukundapuram and Chowghat. There were also 10 teachers training schools and 13 technical schools accommodating respectively 572 and 1284 students. There were 14 colleges for general education besides one for engineering, another for teachers training and one for Veterinary Science.

In the sphere of fine arts, the Kerala Kalamandalam and Natan Niketan Trichur are two important institutions doing valuable service.

The most important institution imparting oriental education is the Sahithya Deepika Sanskrit College at Pavarty. Besides, there are two institutions meant for the education of the handicapped children. They are the school for the defectives at Kunnamkulam and the Government Leper School at Adoor.

The Kerala Sahithya Acadamy and Kerala Sangeetha Nataka Academi are two important cultural organisations functioning in the District.

The Kerala Engineering Research Institute situated at the foot of the Peechi Dam is an important research institute of the State located in Trichur District.

Other note working institutions catering to the educational and cultural life of the people are the All India Radio, Trichur, the Public Library and Reading Room Trichur, the State Museum and Zoological Gardens, Trichur and the Archaeological Museum and Picture Gallery, Trichur.

Out of a total of 603,551 persons listed as workers in the 1971 Census nearly 53% are workers engaged in occupations other than cultivation. Among the remaining 47%, 14 are cultivators and 33 are agricultural workers. The percentage of workers to total population is 28.7.

The net area sown during 1970-71 was 138,679 hectcs which is 47.1% of the total area. About 1.07 lakh hectcs were cropped more than once in 1971 bringing the total cropped area to 2.46 lakh. hect.

Paddy was grown in 1.15 lakh hectcs of land in 1970-71 producing 1.63 lakh tons of rice. The most important perennial crop in respect of area cultivated was coconut covering an area of 54,861 hect. followed by arecanut, with an area of 13261 hect. Other important crops are Tapioca, Bannana, Cashewnut, Rubber, etc.

A total of 36904 hectares were under irrigation during 1967-68. This include only figures of area irrigated by sources other than Minor, Medium and Major Irrigation Schemes (Department).

There were 545 working factories during 1969. The average daily employment was 18081. Among the taluks, Trichur is leading in industrial development followed by Chowghat and Mukundapuram. The most important industry in this District is tile manufacturing. The availability of good

quality clay around Amballur, Karivannoor, Ollur and Pudukad have made these places the important centres of tile industry. Other important industries are the production of beedi and cotton spinning and weaving. Timber, soap manufacture, canning, chemicals, oil mills, printing, etc., are also other industries of the District. Besides, different types of cottage industries and village industries are also working in the District.

There were 17 Allopathic Hospitals in the District. The number of primary health centres was 18 and dispensaries 20 during 1970-71. The total bed strength was 2716. The number of hospitals (indigenous medicine) was 8 and dispensaries 46 with a bed strength of 134.

The total in-patients treated in modern medicine were 143,316 and in indigenous medicine 4,760. The number of out-patients treated in modern medicine and indigenous medicine were respectively 2,596,147 and 1,696,717.

A beginning was made in the development of modern roads and communication more than a century back. During 1844, a road was commissioned during the period of Dewan Sankara Warrier connecting Trichur to Coimbatore. The beginning thus made was progressively maintained. At present, the district has 5683 km of roads of which 1056 km are concrete or tarred roads. There is also 70 km of rail roads in this District (broad gauge). The first railway line was opened in 1902 which was converted to broad gauge in 1935.

Private motor service occupies a relatively more important position in the District. The nationalised motor service has grown in importance during the recent period.

There were 1107 registered good vehicles in the District during 1970-71. The number of registered buses during the period was 558, the number of taxi cars 1087 and the number of private cars 2160.

The co-operative movement was started in 1913 to make available to the ryots credit on fair and safe terms. During 1969-70, there were 8589 non-industrial co-operative societies with a total membership of 2.6 lakhs. Besides there were 31 Coir Co-operative Societies during the period with a membership of 6703. The number of handloom weavers co-operative societies was 19 with a membership of 1989.

At the district level a District Co-operative Bank and a land mortgage bank are functioning. Among the non industrial societies, credit societies lead the rest in numbers (221).

## I. AREA, POPULATION AND HOUSING

This section mainly deals with the area, population and housing, their distribution and characteristics according to 1961 Census. Wherever possible the data from 1971 Census have also been included. All the important aspects such as density of population, growth of population, sex ratio, religion, rural, urban break up, population by age-groups, distribution of households according to tenure, material of roof, number of rooms, material of wall etc., have been dealt with in this section.
