P R E F A C E

The State Domestic Product is estimated annually by the Department of Economics and Statistics based on the guidelines, methodology and definitions prescribed by the Central Statistical Organisation in conformity with the U. N. System of National Accounts. The State Domestic Product thus prepared by the Department is invariably reconciled with the figures prepared by the Central Statistical Organisation before publication.

This issue presents the estimates of Gross State Domestic Product (GSDP), Net State Domestic Product and Per Capita Income for the years from 1993-'94 to 2004-'05, both at Current and Constant (1993-'94) prices. The estimates prepared separately for all the 13 sectors are prescribed in the tables given in the tables given in this issue.

District-wise breakup of NSDP and Per Capita Income at Current and Constant (1993-'94) prices for the period from 2000-'01 to 2004-'05 are also presented in this brochure.

I would like to place on record my appreciation to the officers and staff in the State Income Division who have made earnest efforts in bringing out this publication.

STATE INCOME AND RELATED AGGREGATES

OF KERALA FOR 1993-94 TO 2004-05

State Income is the most important yardstick by which economic development of a country is measured. Net State Domestic Product (NSDP) is defined as the factor income generated within the geographical boundary of a State or it is the sum total of the net value added in the economy in a given period of time. National product is the sum total of the value added in different sectors of the economy of a nation in a specified period including the net factor income added from abroad.

Net Domestic Product or Net National Product at factor cost is the sum total of the earnings of the factors of production in the process of production in different sectors of the economy. It includes rent for land, interest on capital, wages and compensation paid to employees, profit and dividends for the organization. In addition to this, in the case of self employed individuals, since no factor incomes are generated, mixed income of the self employed persons are also included as a constituent of the NDP. In short, the Net Domestic Product is the component of Wages and Salaries, Rent, Interest, Profit and Dividends and Mixed Income of the self employed.

Net Domestic Product at Factor Cost means the income derived by the factors of production excluding indirect taxes while net product at market prices is inclusive of indirect taxes.

State Income is computed with base year 1993-94 in four different categories in each year in-order to find out the difference between real growth and inflationary growth.

1. Net State Domestic Product at constant prices.
2. Gross State Domestic product at constant.
3. Net State Domestic Product at current prices.
4. Gross State Domestic Product at current prices.

In General, National Income is the value of total of the goods and services produced in the economy in a given period. The different economic activities from which the income flows are classified as Primary, Secondary and Tertiary sectors. The Primary sector consists of Agriculture and allied activities while secondary sector comprises of Manufacturing, Electricity, Construction, Gas and Water Supply. Tertiary sector includes Transport, Communication, Trade, Finance, Real Estate, Community and Personal Services.

The State Income finalised by this Division after reconciliation with Central Statistical Organisation figures for the period from 1993-94 to 2002-03 are mainly explained in this report.

STATE INCOME OF KERALA - A BRIEF ANALYSIS

This report contains Estimates of State Domestic Products and Per Capita Income of Kerala at Current and Constant Prices from 1993-94 to 2002-03, 2003-04 (Provisional), 2004-05 (Quick) with the same base year 1993-94, incorporating the details of growth of State Income and percentage contribution of each sub-sector to the total. The District-wise Distribution of the Net State Domestic Product and Per Capita Income of Kerala at Current and Constant Prices from 2000-01 onwards are also included in this publication.

Diagrammatic representations of sector wise contribution of GSDP at current and constant prices, contribution of sub sectors in each of Primary, Secondary and Tertiary sectors at current and constant prices, Year wise comparison of each sub-sectors from 1993-94 onwards etc. are included in this publication. Besides, District level break up of NSDP at current and constant prices from 2000-01 to 2004-05 are also given in this report.

As seen from the tables the share of primary sector both at current and constant prices is less when compared with the tertiary sector. This reveals that the economy of Kerala is shifting from agricultural activities to non-agricultural activities. The increased contribution of Secondary and Tertiary sectors is a good sign of development because in almost all under-developed countries the major contribution to National Income is from agriculture. From 1993-94 onwards the contribution of Primary sector decreases with corresponding increase in Tertiary sector. The contribution of Secondary sector has also been showing an increase over Primary sector since 2000-01.

During the year 2002-03 GSDP at current prices become Rs. 8114577 Lakhs, which shows a growth of 12.1% from the previous year and GSDP at 1993-94 prices become Rs. 4227152 Lakhs, which shows a growth of 8.3% from the previous year. There is a growth of 10.7% in Per Capita at GSDP current prices and 7% in Per Capita at GSDP constant prices from the previous year.

During the year 2002-03 NSDP at current prices become Rs. 7369684 Lakhs, which shows a growth of 13.6% from the previous year and NSDP at 1993-94 prices become Rs. 3754949 Lakhs, which shows a growth of 9.1% from the previous year. There is a growth of 12.3% in Per Capita at GSDP current prices and 7.8% in Per Capita at GSDP constant prices from the previous year.

In the year 1993-94 the contribution of Primary sector, Secondary sector and Tertiary sector in the GSDP current are 30.58%, 20.62% and 48.8% respectively. But during the year 2004-05 (Q), it becomes 16.33%, 22.97% and 60.7% respectively. It shows that even though there is a growth in the Primary sector, its contribution in the GSDP current prices is decreasing. It is because of the increasing contribution of Tertiary sector. The contribution of secondary sector is more or less constant for every year.

In the Primary sector a major portion of the income is originating from Agricultural and Livestock sector only. In the Secondary sector the manufacturing and construction sectors have almost equal importance in the GSDP. In the Tertiary sector Trade, Hotel and Restaurant have an important roles in the GSDP. Proceeding to Trade sector, Transport, storage and communication sector and other services sector have almost equal importance in the Tertiary sector.









Comparison between GSDP at Current and Constant prices (Base Year 1993-94)




Comparison between GSDP Per capita at Current and Constant prices




Sectorial comparison in GSDP Current (Base year 1993-94)






GDP FROM FORESTRY & LOGGING IN CURRENT PRICES (BASE YEAR 1993-94)




GDP FROM MINING & QUARRYING IN CURRENT PRICES (BASE YEAR 1993 - 94)




GDP FROM FISHING SECTOR IN CURRENT PRICES (BASE YEAR 1993-94)




GDP FROM MANUFACTURE (REGISTERED) SECTOR IN CURRENT PRICES (BASE YEAR 1993 - 94)




GDP FROM MANUFACTURE (UNREGISTERED) SECTOR IN CURRENT (BASE YEAR 1993 - 94)






GDP FROM CONSTRUCTION SECTOR IN CURRENT PRICES (BASE YEAR 1993 - 94)






GDP FROM STORAGE IN CURRENT PRICES (BASE YEAR 1993 - 94)



GDP FROM TRADE HOTEL AND RESTAURANT IN CURRENT PRICES (BASE YEAR 1993 - 94)




GDP FROM BANKING AND INSURANCE IN CURRENT PRICES (BASE YEAR 1993 - 94)










Net District Domestic Product at current prices for the year 2000-01(Base year 1993-94)




