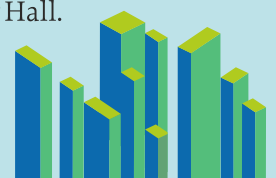


Celebrated Human Rights Day

State Level Meeting of Consumer Price Revision Committee
