



GROSS STATE DOMESTIC PRODUCT OF KERALA

**FROM 1970-71 TO 2008-09
(BASE YEAR 1999-2000)**

INTRODUCTION

In India, after independence, due attention was given to the development of official estimates of national income and related aggregates to meet the requirements for planning and policy purposes. Recognising the need for providing estimates of national income on a regular basis, Government of India set up a High Powered Expert Committee in 1949 known as 'National Income Committee' under the Chairmanship of Prof. P.C. Mahalanobis with Prof. D. R Gadgil and Prof. V.K.R.V.RAO as members. This Committee provided the estimates of national income for the entire Indian Union for the first time. The estimates of national income and details of methodology adopted by the Committee were published in the First and Final reports of the National Income Committee brought out in April 1951 and February 1954 respectively. In accordance with the methodology and the pattern of presentation recommended by the National Income Committee, the first official estimates of national income were prepared by the Central Statistical Organisation (CSO) with base year 1948-49. These estimates at constant (1948-49) prices along with the corresponding estimates at current prices and the accounts of the Public Authorities were published in the publication, 'Estimates of National Income in 1956'.

With the gradual improvement in the availability of basic data over the years, a comprehensive review of methodology for national accounts statistics has constantly been undertaken with a view to updating the database and shifting the base year to a more recent year. As a result, base years of the National Accounts Statistics series have been shifted from 1948-49 to 1960-61 in August 1967, from 1960-61 to 1970-71 in January 1978, from 1970-71 to 1980-81 in February 1988, from 1980-81 to 1993-94 in February 1999 and from 1993-94 to 1999-2000 in January 2006.

The Directorate of Economics and Statistics (DES) is the nodal agency for the coordination of Statistical activities in the State. DES annually estimates the State Domestic Product using the concepts and methodology approved by the System of National Accounts (SNA) of the international agencies and finalise after the reconciliation with CSO.

In Kerala Gross State Domestic Product (GSDP) and Net State Domestic Product (NSDP) estimates at current and constant prices were prepared from 1960-61

onwards in different base years. The GSDP / NSDP estimates of Kerala with base years 1960-61, 1970-71, 1980-81, 1993-94 and 1999-2000 were available. For the purpose of comparison of these estimates, DES made an effort to convert these estimates of GSDP/NSDP in different base years to the same base year 1999-2000.

recession, famine and drought, India did not pay much heed to long term goals. Instead, it responded to the need of the hour. It started taking measures to overcome the crisis.

- ❖ Food grains production increased to bring about self sufficiency in production. With this attempt, gradually a gap was created between the people of the rural areas and those of the urban areas.
- ❖ The need for foreign reserves was felt. This facilitated growth in exports. Import substitution drew considerable attention. All these activities widened the industrial platform.
- ❖ Following the 4th Five Year Plan an alteration in the socio economic structure of the society was observed.

The objective of the 5th Five Year Plan was to increase the level of employment, reduce poverty and to attain self sufficiency in agriculture.

The objective of the 7th Five Year Plan was to generate more scope of employment for the people of India, to produce more in terms of food which would lead to an overall increase in productivity.










