Linking Factor (Base Year 2011-12 with 2004-05)

In order to maintain continuity in the time series data on Index of Industrial Production (IIP), it is necessary to provide a linking factor so that the new series, when released, may be compared with the previous one. Using the Arithmetic conversion method, the Linking Factors for conversion of Indices from the base 2011-12 series to the earlier base 2004-05 series up to sectoral level are as follows:

- Mining & Quarrying Sector index decreased, indicating a negative growth rate of -0.74%
- Electricity sector index increased, indicating a positive growth rate of 40.93%
