

Abstract,—Bureau of Economics and Statistics—Administration Report for 1973-74—Reviewed.

Read.—Letter No. PA1-24355/74/ESD., dated 6th May 1975 from the Director, Bureau of Economics and Statistics.

- 1. Recorded.
- 2. Sri N. Gopalakrishnan Nair continued to be the Director of Bureau of Economics and Statistics during the year under report.
- 3. The Bureau of Economics and Statistics continued to function as the central agency for the systematic collection, compilation, analysis and objective interpretation of all statistics relating to the State besides functioning as an advisory body on economic issues referred to it.
- 4. During the year the Agricultural Statistics Division of the Bureau of Economics and Statistics continued to conduct land utilisation surveys in order to frame the estimates of area under different land uses and area under different crops in the State.
- 5. Sample surveys in respect of rubber, coffee and tea estates for the improvement of plantation statistics were also continued. During the period the division undertook crop cutting surveys on winter and summer crops of paddy 1974 and tapioca 1973-74 and published the report on the crop cutting survey on the annual crop of paddy 1973. As usual, pre-harvest estimates on area under and yield rates of pepper, sugarcane, groundnut and paddy were collected and furnished to the State and Central Governments.
- 6. During the year the agricultural statistics tables for the agricultural year 1972-73 have also been prepared and published. Daily rainfall data were recorded in 89 centres and the daily rainfall statement for the year 1972 was sent to the Deputy Director General of

Observatories, Poona. Forecast reports on area and production of important seasonal crops continued to be prepared and furnished to the Government of India. The unit also published statistics of gross produce per hectare of nine crops specified in rule 41 of the K.L.R. (Tenancy) Rules, 1970, for the year 1973-74 and prepared and sent for printing the season and crop report for 1971-72. The preparation of National Index of Field Experiments was continued as also the cashew and pepper surveys. A new scheme for the conduct of assessment surveys on high yielding varieties programme was also initiated.

- The Prices Division continued to collect statistics of prices. Weekly retail prices of 40 articles were collected from 22 centres for computing the State series of Consumer Price Index Nos. and the statements showing the Index Nos. for various centres were forwarded to important users. Steps have been taken to compute fresh consumer price index numbers for 15 centres of the State, with 1970 as base. Fortnightly reviews of weekly retail prices of specified commodities were prepared and forwarded to the concerned Central and State authorities. Similarly, market rates of dietary articles and other hospital necessaries were collected and supplied to the Health Services Department for use in finalising contracts for their supply. The Market Intelligence Unit continued to provide a regular and prompt supply of news on market rates, market arrivals, etc. of different agricultural commodities. Daily price bullettins and weekly market reviews continued to be broadcast through the A.I.R. The Unit was also engaged in the regular computation of Index Series relating to agricultural economy."
- 8. During the period the division took up the revision of estimates of State domestic product of Kerala for the years from 1960-61 to 1970-71. Provisional estimates for the year 1971-72 and quick estimates for 1972-73 were also prepared. According to the revised estimates, the per capita income of Kerala at current prices increased from Rs. 271 in 1960-61 to Rs. 600 in 1970-71. There is a slight decline in per capita income for the year 1971-72 to Rs. 589 mainly due to the fall in the price of agricultural commodities. The per capita income for the year 1972-73 again went up to Rs. 656. During this period the per capita income at constant prices showed an upward trend from Rs. 271 in 1960-61 to Rs. 346 in the year 1972-73.
- 9. The State Domestic Product at current prices increased from Rs. 1264 crores in 1970-71 to Rs. 1446 crores in 1972-73 and that at constant (1960-61) prices increased from Rs. 714 crores in 1970-71 to Rs. 762 crores in 1972-73.
- 10. The Bureau continued to attend to the work relating to the collection and compilation of statistical data of exports from and imports into the State through the ports in Kerala. It also continued to collect data on buildings, construction activities and furnish returns

to the National Buildings Organisation besides carrying out four rounds of a wage structure survey. The Labour Statistics Unit continued to prepare the returns under the various labour enactments viz. Factories Act, 1948, Payment of Wages Act, 1936, Maternity Benefit Act, 1961, Industrial Statistics (Labour) Rules, 1951, etc., and furnish them to the Labour Bureau, Simla. During this time the Industrial Statistics Unit continued the tabulation and analysis of the schedules on annual survey of industries canvassed by the National Sample Survey Organisation and preparation of reports and undertook two pilot surveys, one on Goods Traffic in Kerala and the other on 'Distributive Trade'. The unit also completed the final report relating to the survey on unregistered industrial establishments for forwarding to the Government of India. As usual the Mechanical Tabulation Unit continued to tabulate mechanically the data relating to Vital Statistics, National Sample Survey and other Sample Surveys.

- 11. During this period the Demographic Research Centre completed a number of useful studies, such as study on the effect of Family Planning Programme on the birth rate in Kerala, a note on the calculation of births averted due to the Family Planning Programme, the characteristics of the population of Kerala and the impact of the Family Planning Programme, a note on the trend in life expectancy in Kerala over the years, Trichur Mass Vasectomy Camp, 1972, an analysis and Family Planning Festival at Cannanore and released publications relating to them. Other studies were in progress. The Vital Statistics Unit continued to collect, compile and publish the Vital Statistics data of the State. All the schemes for the improvement of Vital Statistics were continued during the year.
- 12. The administrative Intelligence Unit continued to attend to the State level consolidation work in respect of the progress of the C.D. Programme, Rural Works Programme, Applied Nutrition Programme, etc. and furnish reports thereon to the State and Central Governments.
- 13. This year also the Bureau of Economics and Statistics continued to participate in the socio-economic part of the National Sample Survey conducted by the N.S.S. Organisation of the Government of India. During the year the field work of the 27th round was completed and that of the 28th round was started.
- 14. The Survey Wing of the Evaluation Division of the State Planning Board which was shifted to the Bureau of Economics and Statistics during this period took up studies on high yielding varieties of paddy and Minor Irrigation (Projects and Pumpsets) for preparation of analytical data for being forwarded to the State Planning Board. Similarly data in respect of evaluation of Soil Conservation Programmes were also prepared and furnished to the Board.

- 15. The Publication and Co-ordination Division prepared, the State Statistical Hand Book 1972, District Statistical Handbooks of Trivandrum, Trichur, Palghat, Kozhikode and Cannanore and a publication called 'Rates and Ratios' and sent them to press for printing. It also initiated work on the State Statistical Abstract, 1973. The Division also looked after the technical requirements of the Statistical Units in other departments.
- 16. The expenditure on the various schemes implemented by the Bureau of Economics and Statistics during 1973-74 was Rs. 47,68,312 as against Rs. 47,19,090 in the previous year.
- 17. The working of the department during the year under report was generally satisfactory.

It is the Central Agency for the systematic collection, compilation, analysis and objective interpretation of all statistics relating to the State and it is also functioning as an advisory body on economic issues referred to it. There are two wings of the Department viz., the Directorate and Field Survey Division. The Director is the head of the Department. The Additional Director is in charge of the Field Set K. A. CHAPTER II

AGRICULTURAL STATISTICS

1. Land Utilisation Survey

The Department continued to conduct Land Utilisation Surveys during the year under report.

The object of the survey was to frame the estimates of area under different land uses and area under different crops in the State.

The survey was conducted from 1st November 1973. The reference period of the survey (both 1st and 2nd rounds) was from 1st July 1973 to 30th June 1974. The survey was conducted in all the 57 taluks. A stracified two stage random sampling design with the taluks as the stratum was adopted for the survey. In each taluk (except Hosdurg and Kasaragode) 15 census villages were selected by simple random sampling method. In the case of Hosdurg and Kasargod Taluks only 12 villages each were selected. From each village 10 clusters of 5 plots each (in the case of Kasargod and Hosdurg 5 clusters of 10 plots each) were enumerated. If a selected village consists of 50 plots or round about, then all the villages were enumerated. During the year a total No.of 42250 plots were enumerated.

During the year under report, details in respect of the first round of the survey (i.e. 1st July 1973 to 31st January 1974) were collected by enquiry method and those of the 2nd round by actual enumeration. The particulars in respect of each round of the survey were entered in separate schedules prescribed for the two rounds.

Data on area under different land uses, area under different seasonal crops, number of various perennial crops and area irrigated under different sources of irrigation were collected. The field work of the survey was in progress during the year.

The analysis of the data collected during the 1st round 1972-73 was in progress. The compilation of the data collected duri g 1971-72 (both 1st and 2nd rounds of the survey) was completed and Statistics of Land Utilisation Survey was finalised. These estimates were used for the preparation of Agricultural Statistics Returns of the State.

2. Improvement of Plantation Statistics

The object of the scheme was to obtain reliable Statistics on the following aspects in respect of rubber, coffee and tea estates in the State.

- 1. Area under crops
- 2. Area from which yield is obtained
- 3. Quantity of yield
- 4. Number of workers employed

The sample surveys on rubber and coffee estates conducted during the year under review was XIII round in the series. The official estimates of area under and production of rubber for the year 1972 and of coffee for the year 1972-73 were prepared.

The tea statistics for the year 1971 was prepared. The collection of tea statistics for the year 1972 was in progress.

3. Crop Cutting Surveys

(i) Crop Cutting Surveys on Paddy 1973-74.—During the period under reference Crop Cutting Surveys on Winter and Summer crops of paddy 1974 were undertaken. The report on the crop cutting survey on Autumn crop of paddy 1973 was published. During crop cutting survey on Winter crop of paddy, the number of experiments was increased to 3000. Necessary funds to meet the additional expenditure were provided by the Department of Agriculture.

The field work relating to Autumn crop of paddy 1974 was completed and the analysis is in progress.

- (ii) Crop cutting survey on tapioca 1973-74.—The survey has been conducted in all the taluks in the State. The estimates of area and production of tapioca in each district and State have been finalised.
- (iii) Pre-harvest estimates.—Pre-harvest data on area under and yield rate of pepper, sugar-cane, groundnut and paddy (Autumn, Winter and Summer) were collected and the estimates have been sent to the Economic and Statistical Adviser, Government of India, New Delhi and the concerned State Gevernment Officers.

4. Agricultural statistics

The Agricultural Statistics Unit dealt with the following items of work during the year 1973-74.

- (i) Collection and compilation of—
 - (a) Agricultural Statistics relating to the State and
 - (b) Rainfall data relating to the State.
- (ii) Preparation of forecast reports on area and prodution of important crops in the State.
- (iii) Preparation of production statistics relating to certain prescribed crops in accordance with K. L. R. Act, 1964.
 - (iv) Preparation of seasonal crop reports.
 - (v) Other miscellaneous items of work.
- 1 (a) The Agricultural Statistics tables for the Agricultural year 1972-73 have been prepared and published. Classification and utilisation of land and its percentage to the total area of the State during the year 1972-73 are furnished hereunder.

1 (b) Daily rainfall data were recorded in 89 centres in the State. The monthly and annual rainfall returns received from these centres were compiled in the section. The daily rainfall statement for the

year 1972 has been sent to the Deputy Director-General of Observatories, Poona.

- 2. The preparation of forecast reports on area and production of important seasonal crops in the State was continued during the year under reference. These reports were forwarded to the Government of India and to the State Government as per the time-schedule fixed.
- 3. During the year under reference the Statistics of gross produce per hectare of nine crops specified in rule 41 of the K.L.R. (Tenancy) Rules 1970 for the year 1973-74 was also published.
- 4. The season and crop report for the year 1971-72 was prepared during the year and forwarded to the Superintendent of Government Presses, Trivandrum for printing. The report for the year 1972-73 was under preparation.

5. National Index of Field Experiments

The preparation of National Index of Field Experiments was continued during the year under report.

The object of this scheme is to put together in one place the result of all field experiments conducted in different parts of the country, whether they are conducted by the State Departments of Agriculture, University of Agriculture, Central Research Institute, Commodity Committees or other organisations. It is intended to catalogue all these materials on a uniform basis and standard manner so that they are available to all the Agricultural Research workers in the country. The field experiments are indispensable for acquiring new knowledge as well as measuring the impact on crop production, the various improvements which may be introduced in agricultural practices.

This Bureau performs collection, compilation and statistical analysis of the data of the field experiments conducted at the various Agricultural Research Stations in the State. The results of analysis of the above data are promptly communicated to concerned Research Stations, State Directorate of Agriculture and the Institute of Agricultural Research Statistics (I.A.R.S.), New Delhi.

6. Other Agricultural Surveys

(i) Assessments Surveys on High Tielding Varieties.—The scheme for the conduct of the Assessment Surveys on High Yielding Varieties Programme was initiated in the State as a fully subsidised scheme of the Institute of Agricultural Research Statistics, New Delhi. The scheme is to conduct yield estimation surveys and Agronomic and Agro-Economic enquiries on paddy in the Districts of Kottayam, Ernakulam, Trichur and Malappuram during the three paddy growing seasons.

During the period under report the yield estimation surveys for sum ner 1972-73 and Autumn 1973-74 were conducted. The Agronomic and Agro-Economic enquiries for Summer 1972-73 were also conducted. The field work was stopped after completing the work relating to the Autumn 1973-74 for want of allocation of sufficient funds for the year. The office staff of the scheme were however allowed to continue for collection scrutiny, coding of the filled-in schedules relating to the surveys conducted. The filled-in schedules were forwarded to the I.A.R.S. for analysis and reporting.

(ii) Cashew Survey.—The Bureau continued to attend to the conduct of the Cashew Survey, designed to estimate the area under cashew cultivation and production of cashew in Kerala State. The following staff were in position throughout the year 1973-74:

The Taluk Statistical Inspectors were in-charge of the survey while 5 Statistical Inspectors were specially appointed for intensive supervision of the work. The District Statistical Officers were in overall charge of the work in their respective districts.

The analysis of the data relating to the two rounds of the survey already canvassed, was attended to in the Head Office and it was in progress in the year under report.

CHAPTER III

ECONOMIC STATISTICS

1. Prices (General)

Prices Division of this Bureau continued to attend to the following items of work.

Weekly retail prices of 40 articles were collected from 22 selected centres. These data are mainly used for computing the State series of consumer price index numbers. At present index numbers are computed for the following 13 selected centres in the State.

The base for Kozhikode is the average price for the year ended June 1936=100 and for other centres the base period selected is August 1939=100. The monthly index numbers were computed and published regularly in the Gazette.

Statements showing the index numbers for various centres in the State were forwarded to important users—both public and private, individuals and organisations—direct from this Bureau. Steps have been taken to compute fresh consumer price index numbers for 15 important centres of the State, with 1970 as base. Government orders to this effect are awaited.

This Bureau continued to collect weekly retail prices of 73 specified commodities from all district headquarters and prepare reviews

indicating their price trends, availability and apprehended scarcity. These fortnightly reviews with consolidated fortnightly statements of prices were forwarded to (1) The Secretary to Government, Food Department, Secretariat, Trivandrum, (2) The Section Officer, Economic Division, Planning Commission, Yojana Bhavan, Parliament Street, New Delhi, (3) Sri S. Krishnakumar, Director of Civil Supplies, Board of Revenue, Trivandrum and (4) The Director-General (Civil Supplies), Ministry of Industrial Development, Udyog Bhavan, New Delhi.

The collection of retail prices from the five centres of Alwaye, Ernakulam, Quilon, Mundakayam (old and new series) and Alleppey (old series) for the Labour Bureau, series of consumer price index numbers (central series) also continued.

The Bureau continued to collect the market rates of dietary articles and other hospital necessaries for the use of the Health Services Department, Department of Indigenous Medicines, etc. for finalisation of contracts for supply of the articles to the institutions under their control. The collection of prices was done on a quarterly basis on the first Friday of every quarter for the Health Services Department. The Statistical Inspectors were made responsible for the collection of prices of 200 items. The market rates of these 200 items of dietary and other allied articles were collected for every quarter. The data were scrutinised and finnal statements of prices for 57 centres prepared and furnished to all the District Medical Officers, District Indigenous Medical Officers, Director of Health Services, Director of Indigenous Medicines, Medical Colleges, T.B. Hospitals, E.S.I. Hospitals, Poultry Centres and Cattle Farms under the Department of Animal Husbandry, Director of Museums and Zoos, Jails, Army Commander for Tamil Nadu and Kerala etc. Data on prices of dietary articles required by other departments and institutions were also furnished when requested for.

Also prices of over 1000 Ayurvedic medical items were collected in January 1974, scrutinised and final statements of prices prepared and forwarded to the two Government Ayurvedic Colleges and Research Centres at Trivandrum and Tripunithura.

Rural retail prices.—Information on monthly retail prices of 28 commodities is being collected from 21 selected villages in the State. This data are being collected for computing rural price index.

2. Market Intelligence

The main object of the scheme is to provide for the benefit of the primary producers, a regular and prompt supply of news on market rates, market arrivals etc., of different agricultural commodities produced by them. The scheme is in operation in 36 important market centres of the State.

The field work of the reporting agencies under the scheme is supervised by the respective District Statistical Officers and two Regional Price Supervisors posted at Trivandrum and Kozhikode.

The price collection work in all the district headquarters except Idikki is being attended to by full-time Price Inspectors. In addition to this there are 3 Price Inspectors posted at Changanacherry, Kozhikode and Cochin. There are 5 full-time Price Reporters working at Kadakkal, Irinjalakkuda, Crangannore, Kunnamkulam and Baliapattom. The price collection work at the remaining centres are being attended to either by Junior Statistical Inspectors or Investigators.

Daily price bulletins containing the information in prices in respect of 26+10 centres are prepared in the Regional Offices, Trivandrum and Kozhikode respectively. The same is sent to the regional stations of All India Radio, Trivandrum/Kozhikode for broadcast during the radio rural or karshikarangam programme in the evening.

Weekly market review.—A weekly market review in Malayalam on price, price trends etc., of important agricultural commodities in respect of selected centres is prepared and broadcast in the evening on every Sunday.

Daily report on open market price of rice.—A daily statement on the open market price of rice prevailing in the different district head-quarters of the State is also prepared and furnished to Government of India, State Civil Supplies authorities of the Board of Revenue. In addition to this, the Reserve Bank of India is also being supplied with the weekly market price of rice available in the open market of Palghat centre. In addition to this, various requirements in respect of wholesale prices, of many other offices both Government of India and the State are regularly met by this scheme.

3. Index series

Index series (relating to Agricultural Economy).—The above scheme is intended for the regular computation of the following indices:—

- (a) Index numbers of wholesale prices of agricultural commodities, (b) Index numbers of parity between prices received and paid by farmers (c) Index of agricultural wages.
- (i) Index numbers of wholesale prices of agricultural commodities.— Seventeen important agricultural commodities are included in the computation of the wholesale price index. The monthly indices were computed on the basis of the wholesale prices collected from the various reporting centres distributed throughout the State. The base

year selected is the agricultural year 1952-53. The wholesale price index numbers were computed every month.

- (ii) Index numbers of parity between prices received and paid by farmers.— This index measures the variation in the economic prosperity of the farmers relating to changes in farm prices, farm cultivation cost and domestic expenditure as compared to the situation during 1952-53. The parity index numbers between prices received and paid by farmers have been computed for all months of the year under reference.
- (iii) Index of agricultural wages.—The data on agricultural wages were collected from the selected centres in the State and sent to the Economic and Statistical Adviser, Government of India and published in the Kerala Gazette. The monthly indices of wages of rural skilled workers and agricultural labourers were regularly computed and forwarded to the Government of India.

In addition to the computation of the above indices, this section attended to the following items of work also: (1) Fortnightly farm prices of cocoanuts with husk were tabulated and sent to the Secretary, India Central Cocoanut Committee, Ernakulam, (2) Yearly weighed average farm prices of 9 commodities were worked out and sent to the Economic and Statistical Adviser, New Delhi, (3) Fortnightly farm prices of cocoanut with husk were sent to the Deputy Director (Agriculture), Nileswar, (4) Weekly statement on prices of coir and husk were prepared and sent to the Secretary, Coir Board, Ernakulam, (5) Monthly average prices of coir were sent to the Government Press, Trivandrum for publication in the Government Gazette, (6) Weekly prices of export staples at Mattancherry and Alleppey were sent to the Government Press for publication in the Gazette and (7) Data on farm prices were supplied to outside agencies on request.

4. State income

During the year under report the Division took up the revision of estimates of State domestic product of Kerala for the years from 1960-61 to 1970-71. The estimates were revised on the lines recommended by the Central Statistical Organisation and in the light of the availability of fresh data. Provisional estimates for the year 1971-72 and quick estimates for the year 1972-73 were also prepared. Now, this Division is engaged in the estimation of working force classified according to their major activity for the inter-censual period of 1961 and 1971 and State income estimates for 1973-74. According to the revised estimates, the per capita income of Kerala at current prices increased from Rs. 271 in 1960-61 to Rs. 600 in 1970-71. There is decline in the per capita income in the year 1971-72 to Rs. 589 mainly due to the fall in the price of agricultural commodities. The

per capita income for the year 1972-73 again went up Rs. 656. During the period the per capita income at constant prices showed an upward trend from Rs. 271 in 1960-61 to Rs. 346 in the year 1972-73.

The State domestic product at current prices increased from Rs. 1264 crores in 1970-71 to Rs. 1446 crores in 1972-73 and that at constant (1960-61) prices increased from Rs. 714 crores in 1970-71 to Rs. 762 crores in 1972-73. There was an increase of 14 per cent in the State domestic product for 1972-73 compared to that in 1970-71. The corresponding increase in State domestic product at 1960-61 prices was 6.7 per cent.

5. Export and import statistics

During the period under report the bureau continued to attend to the work relating to the collection and compilation of statistical data of exports and imports from and into the State through the Ports of Kerala.

The monthly statements on seaborne trade received in a coded form from the Director General of Commercial Intelligence and Statistics, Calcutta for the period from January to December 1972 were decoded and tabulated during the year. Preparation of port-wise, commodity-wise and country-wise monthly statements was completed up to 1972 during the year. The Director General of Commercial Intelligence and Statistics, Calcutta has discontinued the supply of monthly statements of exports and imports since May 1973.

Efforts are being made to make alternate arrangements to collect the data from the port authorities/custom authorities in Kerala.

The collection of data relating to railborne statistics remained suspended during the year.

6. Housing and wage statistics

The following items of work were continued during the year under report.

(i) Housing.—The unit in the Public Works Department collected and consolidated the half yearly returns relating to building construction activities costing Rs. 20,000 and above undertaken by the State P. W. D. (Buildings and Roads) for the half year ending 30th September 1972. The quarterly returns on prices of building materials and wages of building labour pertaining to 14 divisions of the P.W.D. for the quarters ending 31st March 1973 and 30th June 1973 were also collected by the cell. The cell forwarded the above items of statistics to the co-ordinating cell in the Bureau of Economics and Statistics for scrutiny and re-transmission to the National Buildings Organisation, Government of India.

The Unit in the Directorate of Municipalities collected and consolidated quarterly returns relating to house construction activities of private builders coming within the purview of the Municipal towns. Apart from this, prices of building materials and wages of building labour from Shertallai, Alwaye and Tellicherry Municipalities for the 4 quarters (31st March 1973, 30th June 1973, 30th September 1973 and 31st December 1973) were also collected and forwarded to National Buildings Organisation.

The co-ordination cell in the Bureau of Economics and Statistics, scrutinised the data received from the other two cells and forwarded the same to the National Buildings Organisation. It collected quarterly returns (private sector) relating to building construction activities directly from the City Corporations of Trivandrum, Cochin and Calicut, consolidated the statements and forwarded them (along with a copy of the returns) to the National Buildings Organisation.

(ii) Wage structure survey.—The survey conducted on a random sampling basis, covers the rural and urban areas of the State. Four rounds of the survey were carried out in all the districts of the State during the year under report. Tabulation and consolidation of the data for the year 1972-73 was almost completed.

CHAPTER IV

OFFICIAL STATISTICS

1. Labour statistics

The following items of work were attended to in the labour statistics unit of this Bureau during the year under report.

- (i) Annual returns under the Factories Act, 1948.—Data contained in the annual returns under the Factories Act, 1948 for the year 1971 (Calendar year) were processed and the various statements required by the Labour Bureau, Simla were prepared. The statements were sent to the Government of India. Annual report on the working of the Factories Act, 1948 in Kerala for the year 1971 was also prepared and sent to the Director, Labour Bureau, Simla.
- (ii) Half yearly returns under the Factories Act.—For the half year ending 30th June 1972 were also processed and the statement on number of factories, average daily employment, mandays worked, etc. was prepared and sent to the Director, Labour Bureau, Simla.
- (iii) Annual returns under the Payment of Wages Act, 1936.—The statements under the Act for the year 1971 were prepared and forwarded to the Director, Labour Bureau, Simla.
- (iv) Directory of Industrial Establishments in India.—A Directory of Factories in Kerala registered under the Factories Act as on 31st December 1971 has been prepared alphabetically.

- (v) Maternity Benefit Act, 1961.—Annual Statements I and II on the working of the Maternity Benefit Act for the year 1973 were prepared and sent to the Government of India.
- (vi) Quarterly returns under the Industrial Statistics (Labour) Rules, 1951.—Returns relating to the Plantations for the 4 quarters of 1972 were processed and the statements required by the Government of India were prepared and sent to the Labour Bureau.
- (vii) Monthly returns on Industrial Disputes.—Monthly returns on Industrial disputes resulting in work-stoppages for the various months of the year under report were also collected. The consolidated statements were sent regularly to the Labour Bureau, Simla.

2. Industrial statistics

The Industrial Statistics Unit of the Bureau is attending to the collection, tabulation and analysis of the statistical data pertaining to the Industrial establishments in the State on a continuing basis.

This unit is attending to the tabulation and analysis of the schedules on annual survey of industries canvassed by the National Sample Survey Organisation, Government of India from registered factories in the States and preparation of reports presenting district—wise and industry-wise data.

This unit is also in charge of a sample survey on un-registered industrial establishments in the rural areas of the State. A pilot survey on 'goods traffic in Kerala' and another pilot survey on 'distributive trade' were undertaken by this unit. The field work of these surveys were in progress during the year.

The tabulation work relating to the annual survey of Industries 1968 and 1969 was completed and the reports prepared. The tabulation work relating to 1970 was started.

The survey on unregistered industrial units in the rural sector as in the previous year was continued during the year under report also. The field work of 1973 round of the survey was completed in another set of 140 selected revenue villages during the reference period. The tabulation of the data collected through the 1972 and 1973 rounds was in progress during the year.

The final report relating to the survey on unregistered industrial establishments in the urban areas (Centrally sponsored scheme) was completed and forwarded to the Government of India during the year.

3. Mechanical Tabulation Unit

The Mechanical Tabulation Unit consisting of 40 col. machines and 80 col. machines were in existence during the year 1973-74 also. The units consist of the following data processing equipments and staff:—

The 40 col. Unit has undertaken the work of punching, verifying and tabulating data on vital statistics for the State. The tabulation of vital statistics data for the year 1971 was completed and tables presented. The suppliers of the machines, viz., The International Computors (India) P. Ltd., discontinued maintenance of the equipments with effect from 1st January 1974 for want of spares. The unit has thus served for two more years than the normal period of guarantee of 7 years. Though maintenance was withdrawn, the machines were utilised up to June 1974.

Vital statistics data for the year 1972 has been taken up for punching, verification and processing in the 80 col. machines in addition to National Sample Survey and other sample surveys during the year under reference. Cards in respect of 23rd round National Sample Survey 0·1 and 0·2 schedules and that of the 24th round schedule 2·4 were taken up and the work completed. All the tables in respect of 24th round National Sample Survey, schedule 16 were prepared and presented. The 80 col. unit is now attending the analysis of data on vital statistics, National Sample Survey and other sample surveys.

VITAL STATISTICS AND DEMOGRAPHIC RESEARCH CENTRE

1. Demographic Research Centre

The Demographic Research Centre in the Bureau of Economics and Statistics, Trivandrum was started in August 1958 for conducting investigation on fertility, family planning, mortality and migration.

The following items of work were undertaken by the Centre during the year under report.

A. STUDIES COMPLETED

(i) On the effect of family planning programme on the birth rate in Kerala.—This paper presents the impact of family planning programme on couples protected from pregnancy and on the extent of reduction in birth rate.

It is seen that nearly 20 per cent of the couples are currently protected by the three methods of family planning namely, sterilisation, I.U.C.D. and conventional contraceptives. The paper brings to light the reduction in birth rate from 38.9 per 1000 during 1951-60 to 31.8 in 1972, in Kerala due to family planning programme. The birth rate might be still lower if the increase in age at marriage, abortion etc., are also considered. While a reduction of 7 points has occurred in birth rate in Kerala due to family planning alone, the estimated all India reduction in the birth rate based on Sample Registration Scheme and also by calculating the births averted by family planning methods, has been 5 points only.

It is worthwhile to note that Kerala has achieved the goal of reduction of birth rate to 32 per 1000 by the end of the 4th Five Year Plan.

(ii) A note on the calculation of births overted due to the family planning programme in Kerala.—This note presents the methodology of calculating births averted due to the various methods of family planning programme in Kerala.

Following the model presented by Sri S. P. Jain in "Estimation of Population growth under Family Planning Programme" for India as a whole, but with parameters that are available for the population of Kerala, the actual calculation is explained in detail and the births averted over the years by each of the methods are worked out. The impact of the births averted till 1972, on the birth rates and the resulting population during each of the years, as also the impact on birth rate till 1980, assuming the fulfilment of the targets set out in the fifth plan, are also worked out and presented in the paper.

The total number of births averted, till the end of 1972, is estimated as 5.42 lakhs due to sterilization, 1.27 lakhs by I.U.C.D. and 0.10 lakh by conventional contraceptives. Considering the effect of non-programme methods, the total number of births averted comes to 7.64 lakhs.

As a result of the births averted, the birth rate is estimated to have come down from 38.9 in 1951-60 to 31.8 per 1000 in 1972.

Calculation of births averted by the future family planning programme gives a birth rate of 24.6 for 1980, assuming that the Fifth Plan targets for the State are fully achieved. The Kerala is achieving the goal of reduction of birth rate to 32 by the end of the 4th Five Year Plan (1973-74) and to 25 two years after the end of the Fifth Plan.

(iii) The characteristics of the population of Kerala and the impact of the Family Planning Programme in Kerala.—The paper attempts, to trace the growth of population in the State, to analyse the changes in the distribution and characteristics of the population and to assess the impact of the family planning programme, as far as data permit.

The rates of growth of population in Kerala have always been higher than that of the Indian Union since 1901. The northern districts of Kerala show a much higher growth rate than the southern districts during 1961–71. When compared to All India and other States, Kerala has the highest density, the higher level of literacy and the excess of females over males in the total population. Alleppey district has the highest density of population in the State and highest literacy rate in the State. Trichur district has the highest sex-ratio. As per 1971 census, only 29.1 per cent of the population of Kerala are workers. A comparatively larger percentage of workers is reported under Agricultural labourers.

The birth and death rates of Kerala for 1970-71 are 30.9 and 9.2 respectively as per Sample Registration (Rural) estimates. The death rate of Kerala is the lowest among the Indian States. The expectation of life at birth has been raising in Kerala during the past decades. The expectation of life at birth for males has increased from 46.2 in 1951-60 to 60.6 years in 1971 and that of females from 50.0 in 1951-60 to 61.2 years in 1971.

This paper also presents in brief, the set up of the family planning programme, progress attained in its implementation and the demographic impact of achievements so far made. Sterilisation operations and the use of conventional contraceptives have considerably increased during the past few years. But the progress of I.U.C.D. insertions has shown a decreasing trend. It is estimated that 19.98 per cent of couples are currently protected by all methods of Family Planning. As 80 per cent of the couples are unprotected, redoubled efforts have to be made on the family planning front.

(iv) A note on the trend in life expectancy in Kerala over the years.—
This paper attempts to present the trends in life expectancy by considering the life tables constructed earlier for the decades from 1911-20 to 1951-60 and the life table constructed from the age specific death rates estimated from the Sample Registration Scheme for rural areas in Kerala 1971.

With the mortality levels in 1971, the expectation of life at birth for the total population works out to 60.86 years (60.57 years for males and 61.16 years for females). At age 5, the gain in expectation of life is the maximum, from 34 years in 1911-20 to 62 years in 1971 for males and from 35 years in 1911-20 to 64 years in 1971 for females. At the age of 60, the gain is from 7 years in 1911-20 to 16 years in 1971 for males and from 8 years in 1911-20 to 16 years in 1971 for females. Between the periods 1911-20 and 1921-30, the annual increases are higher for females except at the age 60 while between 1921-30 and 1931-40 the reverse is the case. During the two decades, 1931-40 to 1941-50 and 1941-50 to 1951-60 also the annual increases for females are higher except for the age 60. Between 1951-60 and 1971, the average increase for males at birth is nearly one year decreasing to a third of the year towards the end. The increases for males are higher than for females.

The population of Kerala, is tending to reach the final stage of demographic transition.

(v) Trichur Mass Vasectomy Camp 1972—An Analysis.—The study analysis (1) the demographic and socio-economic characteristics of the persons sterilised at the camp, (2) the cost of running the camp and (3) the demographic impact of the camp. It also gives an account of the rejected cases from among the people turned up for vasectomy at the camp.

20223 vasectomy operations were conducted at the camp as against a target of 15,000. 699 tubectomy operations were also done. 9.6 per cent of the total cases registered, were rejected due to various reasons. The higher incentive offered at the camp might have attracted them.

40.5 of the vasectomised persons belong to the broad age group of 30-39 years, while 49.4 per cent are below 40 years of age. The mean age of the vasectomised persons is 40.29 and that of their wives is 33.15. Of the sterilised males 71.6 per cent are Hindus, 21.6 per cent are Christians and 6.8 per cent are Muslims as against their percentages of 61.1 per cent, 25.2 per cent and 13.7 per cent respectively in the total population. 71 per cent of the vasectomised persons are below the level of primary education. Majority of the male acceptors belong to the low income category and agricultural labourers and unskilled workers. Among the vasectomised persons, 42.4 are having 3 or less than 3 children living of the tubectomy acceptors,

42.8 are having less than three children. The average expenditure per operations works out to Rs. 92. It is estimated that 53142 births would be prevented during the course of 23 years from 1973 onwards.

(vi) Family Planning Festival at Cannanore (11th March 1972 to 10th April 1972).—The study analyses the socio-economic and demographic characteristics of persons who accepted vasectomy at the camp.

15409 persons were sterilised at the camp. The median age of males who have undergone vasectomy operation in Cannanore camp is 40·25 years and that of their wives is 30·9 years. 52 per cent of the persons sterilised at the camp are above 40 years of age. 80 per cent of the wives of the sterilised males are in the age group of 25–39 years. Among sterilised persons Hindus are over represented, christians are fully represented and Muslims are under represented. Among the persons sterilised, 27 per cent are illiterate, 69 per cent are literate below matric standard and 4 per cent are above matric standard. 85 per cent of persons sterilised at the camp have a monthly income less than Rs. 100 per month. Majority of persons sterilised belong to cultivators, agricultural labourers and unskilled workers. The average number of children living to a sterilised person is 4·17 at the time of sterilisation. Among the sterilised persons, 6 per cent have no male children living and 9 per cent have no female children living at the time of sterilisations done in the camp in the course of the coming 23 years.

The following reports are under finalisation:-

- (i) Some characteristics of migrants in Kerala.
- (ii) Revised edition of Fact Book on population and Family Planning.
 - (iii) Follow up Survey of persons sterilised at the Mass Vasectomy Camp at Trivandrum.

Further, the study of the demographic characteristics of sterilised persons and IUCD (1970-71), resurvey on attitude to Family Planning and follow up survey of persons sterilised at Mass Camp, Palghat are in progress.

- D. Publications released from the Demographic Research Centre
- (i) On the effect of Family Planning Programme on the birth rate in Kerala.

E. OTHER ACTIVITIES

- Dr. R. S. Kurup, Deputy Director (Population) attended the All India Conference on Sample Registration held in New Delhi in August 1973 and also took part in the annual and Vth Plan discussions on Statistical Schemes and Family Planning in New Delhi in August 1973. He attended the State Family Planning Council meeting held in Trivandrum on 3rd February 1974.
- Sri P. S. Gopinathan Nair, Assistant Director participated in the Seminar on Population Growth Targets, organised by the Committee for International Co-ordination of National Research in Demography (C.I.C.R.E.D.) held at Port of Spain, Trinidad and Tobago (West Indies) from 3rd April 1973 to 9th April 1973.
- Sri G. Surendranathan Nair, Research Officer attended the Seminar on Family Planning Research Studies done in Southern Region held at Madurai under the auspices of the Gandhigram Institute of Rural Health and Family Planning, Madurai from 3rd to 5th January 1974.

The Officers of the Population Division are associated with the Orientation Training Course to Medical Officers at the Orientation Training Centre, Neyyattinkara. The Deputy Director gave lectures on Demography to the Post-graduate Students in Preventive Medicines in the Medical College, Trivandrum in September 1973. Dr. R. S. Kurup also spoke on demographic trends at the Regional Family Planning Training Centre, Calicut in July 1973.

2. Vital Statistics

- (i) The Vital Statistics Unit of the Bureau continued to attend to collection, compilation, analysis and publication of reports of vital statistics of the State.
- (ii) Source of data.—As per the Registration of Births and Deaths Act No. 18 of 1969, the Executive Officers of the Panchayats and the Corporation and Municipal Commissioners are the Registrars of Births and Deaths. They are attending to the work of registration of vital events and are sending the reports to this office for compilation, analysis and publication.

The Registrars of the Corporation and Municipality having population more than 30,000 have to send the returns to this office every week and the other registrars have to send the reports every month. For the smooth flow of returns to this office the department is availing itself of "The Service Unpaid System" of the Postal Department.

(iii) Processing of data .- The returns received in this office are coded and forwarded to the Mechanical Tabulation Unit for punching, sorting and tabulation.

The tabulated information are published in the form of Vital Statistics Bulletin. So up. Henry Director (Postel)

The work relating to the preparation of V. S. Bulletin for the year 1971 was almost completed during the year under report.

- (iv) Periodical statements.—The following are the out-going periodicals.-
- 1. Weekly statement of total number of births, maternal deaths and deaths due to communicable diseases relating to towns and cities having population more than 30,000.
- 2. Annual statement of births and deaths.

The periodicals are sent to the Director-General of Health Services, New Delhi, Registrar-General of India, Director of Health Services, Trivandrum and the Superintendent of Government Presses for publication in the Government Gazette.

- (v) Improvement of Vital Statistics .- The following schemes for the improvement of Vital Statistics were continued during the year:
- at 11. Sample Registration.
- 2. Model Registration in Rural Health Centres.
- 3. Strengthening of Vital Statistics organisation Headquarters.
- 4. Mechanical Tabulation Unit at Headquarters.
 - Strengthening of District Statistical Offices.
- Strengthening of Statistical Units in all Municipal and Corporation Offices and in Guruvayoor Township except the Municipalities of Punalur, Chalakkudy, Malappuram and Tirur where the staff for the Vital Statistics Work were not posted.
- (vi) Strengthening of District Strtistical Offices .- Under this scheme one Additional District Statistical Officer and one L.D. Compiler were posted in each District. They attend to the timely flow of returns to this office from the Primary Registration Centres. One of the important items of work of the Additional District Statistical Officer is to carry out effective spot checks in selected areas to spot out unregistered events and make arrangements to get them registered. Also the

Additional District Statistical Officer supervises the work of the statistical staff posted in the Corporations and Municipalities of the concerned district.

3. Improvement of Vital Statistics in Municipalities/ Corporations

As in the previous years, the scheme was in operation in the 3 Corporations and 25 Municipalities and in Guruvayoor Township during the year 1973-74 in order to improve the registration of vital events by conducting spot checks.

The State-level reports of this scheme for the years 1970 and 1971 are under preparation.

(i) Model Registration.—Survey on cause of death.—This scheme is implemented in 18 Primary Health Centres in the State, with a view to improve the cause of death statistics in rural areas. Under the scheme the cause of death is recorded by the para-medical staff working in the Primary Health Centre and the forms are forwarded to this department by the Medical Officer, after scrutiny. The forms are consolidated and monthly and half yearly reports are forwarded to the Registrar-General of India.

Sri N. Vikraman Nair, Research Officer, Vital Statistics Section of this Bureau was deputed to the Registrar-General's Office, New Delhi for training on survey of cause of death (Model Registration) during the period from 10th September 1973 to 15th September 1973.

(ii) Medical certification of cause of death.—The scheme envisages the collection of reliable cause of death statistics. It was in operation in Trivandrum, Cochin and Calicut Corporations and in the two major Municipalities viz. Quilon and Alleppey with population above one lakh. The scheme was working satisfactorily during the year under report.

The reports on 'cause of death' relating to Alleppey and Quilon Municipalities for the year 1972 are being finalised.

ADMINISTRATIVE INTELLIGENCE

During the year under review, the Administrative Intelligence Unit of this Bureau continued to attend to the various items of work in respect of Community Development Blocks.

The data required in the prescribed forms are being furnished by the Junior Statistical Inspectors in the blocks to this office. As usual, the State-level consolidation work relating to the quarterly progress report on Community Development Programme, Rural Works Programme, Applied Nutrition Programme, Local Development Works and Yuvak and Mahila Mandals Programme were attended to by the staff of the headquarters. Annual Progress Report, Part I and Part II of the C.D. Programme and the Tribal Development Block, Attappady and quarterly review on Rural Works Programme were also prepared at the headquarters.

All the reports prepared at the headquarters were submitted to the State Government and Government of India.

OTHER SAMPLE SURVEYS AND PILOT SURVEYS

1. National Sample Survey

- (i) Organisation.—The National Sample Survey Organisation, Government of India, which came into existence in 1950, has been conducting sample surveys every year on a nation-wide basis to collect socio-economic data relating to different sectors of the economy of the country for planning and other administrative purposes. The National Sample Survey (N.S.S.) is a continuing multi-subject, integrated survey being conducted in the form of successive rounds, each round covering some topics of current interest. The State has been participating in the socio-economic part of the surveys on a matching basis. During the year 1973–74, the field work of the 27th round was completed and the operation of the 28th round taken up. The field work of the 28th round was started on 1st October 1973 and was scheduled to be completed by the end of June 1974. The survey covered the entire State.
- (ii) Subject coverage.—For the Socio-economic enquiries, there were four household schedules. They were schedules for household consumer expenditure (Schedule 1·0), housing condition (Schedule 1·2), population, births, deaths, disability and morbidity (Schedule 12) and fertility, maternal and child-care and family planning (Schedule 14). Information on normal health facilities available to the households of sample villages were collected in the listing schedule in the rural sector only. Data on new buildings completed, new buildings under construction, additions and alternations and improvements in the existing dwellings, covering all types of buildings, viz. pucca, semi-pucca and kutcha were collected both in rural and in urban areas in this round

through the respective listing schedules. Also, data on physically handicapped and mentally affected persons were collected through the respective listing schedules, both in rural and in urban areas. A list of schedules canvassed in the 28th round is given below:

- (iii) Sample Design—(a) Rural.—The sample design for the rural sector was a stratified two stage one in which the 1st stage units were census villages (1971 census) and they were selected with probability proportional to size. The State has been divided into 19 strata. The Second stage units were households. In all 360 villages were selected for the 28th round.
- (b) Urban.—The design was a stratified two stage one in which the 1st stage units were urban blocks and the second stage units were households. A total of 144 blocks were selected for the 28th round of N.S.S.
- (iv) Field work.—The field work was done by the Investigators specially posted for the work by interviewing the members of the selected household. Their work was supervised by the Statistical Inspector (N.S.S.) and Additional District Statistical Officers.
- (v) Tabulation.—During the year, the tabulation of the data on 'Economic condition of the weaker sections' collected during the 25th round and the consumer expenditure data (19th round) was completed.

In addition to the above, the entire staff sanctioned for the evaluation of Soil Conservation Survey viz. one Research Officer, one U.D. Compiler and 3 L.D. Compilers (posted in the State Planning Board on working arrangement) were also ordered to be shifted to the Bureau of Economics and Statistics. Accordingly the survey wing was shifted from the State Planning Board and continued to function during the year as part of the Bureau of Economics and Statistics from 30th March 1973.

Studies undertaken during the year 1973-74:

- 1. Survey on High Yielding Varieties of paddy (Virippu, Mundakan and Punja crops)
 - 2. Minor Irrigation (Projects)
 - 3. Minor Irrigation (Pumpsets)

The field enquiries and tabulation work on "Minor Irrigation Projects" were completed and the analytical data forwarded to the State Planning Board for drafting the report. The field work of the evaluation survey on Minor Irrigation (Pumpsets) was completed. The field survey on "the high yielding variety of paddy (Virippu crop)" was taken up and completed during the year. Analysis of the data collected was in progress.

Tabulation and analysis of the data collected in respect of evaluation of Small Industries and Industrial Co-operatives were also completed and the analytical data of the same were forwarded to the State Planning Board for drafting and releasing reports.

2. Evaluation of Soil Conservation Programmes in 1973-74

- (i) The third round evaluation survey on the Kundah Project (Kerala portion) was commenced and completed during the year.
- (ii) The Evaluation Studies (case studies) on Manaloorthazham cheme was taken up in Trichur District and the field enquiry was completed during the year.

The tabulation and analysis of the data collected through the field survey on the evaluation of soil conservation programme in the Hilly Agriculture land (1st and 2nd rounds) covering all the districts in the State in 1971 and 1972 were completed and furnished to the State Planning Board for further action.

The data gathered in connection with the evaluation studies conducted in 1971 and 1972 on the Soil Conservation works carried out in the two sub catchment of Kunda Project (Kerala portion) were completed and the analytical data forwarded to the State Planning Board for drafting and releasing of reports.

PUBLICATION AND CO-ORDINATION


