

P r e f a c e

Ministry of Agriculture and Rural Development, Government of India is conducting Agricultural Census on an All India basis in all the States and Union territories once in five year from 1970-71 onwards. Kerala State also participated in all the four censuses.

Due to administrative and technical reason the field work on Main Census in our state could be conducted only during the period December 1987 - June 1988. The main census was conducted by the investigators of the department under the immediate supervision of taluk level and district level officers.

This preliminary report is brought out on the basis of data collected in the schedule designed for listing of households in the sample wards/divisions selected to avoid time lag.

I am much thankful to the officers of Agricultural Census Division, Ministry of Agriculture and Rural Development, Government of India for the valuable suggestions and advice in the conduct of the census.

I place my sincere thanks to all the officers who have rendered their valuable and whole hearted co-operation for bringing out this report.

I hope that this report will be useful to the planners and administrators in stream lining schemes beneficial to marginal and small farmers.



AGRICULTURAL CENSUS 1985-86

Preliminary report

1. Introduction

The first comprehensive Agricultural Census was conducted in India with agricultural year 1970-71 as the reference period. Encouraged by the utility of data generated, it was decided to undertake the agricultural census at intervals of five years. Accordingly the second and third agricultural censuses were conducted with reference years 1976-77 and 1980-81 respectively.

The fourth agricultural census 1985-86 was carried out in our State during the period December 1987 to June 1988. Due to certain technical and financial problems, there was some delay in undertaking the census in the state. In order to minimise the effect of memory lapses on the part of the respondents, Government of India agreed to shift the reference period of main census from 1985-86 to 1986-87 in our state. In states like Orissa, Bengal and Kerala where a comprehensive system of land records does not exist, required details are being collected by conducting sample surveys.

2. The survey

The agriculture census 1985-86 is comprised of two phases Main census and Input survey. Under the main census, information is collected in respect of (i) number and area of operational holding, (ii) tenure and tenancy status, (iii) land utilization, (iv) sourcewise irrigated area, (v) irrigation status, (vi) area under crops. Under the input survey, information was collected in respect of (i) multiple cropping (ii) application of chemical fertilizers, manures and pesticides, (iii) livestock, (iv) agriculture machinery and (v) rural credit. Besides information regarding number of parcels, area water logged and alkaline land was also collected. In addition to this, all information relating to main census was collected separately for scheduled castes and scheduled tribes also.

For the present census, development block was considered as the stratum of the in rural area and municipality/city corporation in urban area. 20% of the wards in each block and 10% of the wards/division from each municipal/city/corporation area were selected using systematic random sampling method. Altogether there were 2166 sample wards, 2041 wards in rural area and 125 wards/divisions in urban area.

The main object of agricultural census is to collect size class wise information in respect of operational holding as distinct from ownership holding. An operational holding is defined as all land which is used wholly or partly for agricultural production and is operated as one technical unit by one person alone or with others without regard to title, legal form, size or location. The technical unit has been defined as that unit which is under the same management and has the same means of production such as labour force, machinery and animals. This implied that the holding might be either fully owned or fully rented or partly owned or partly rented or cultivated under any other arrangement. The land of the holding might be located in one single compact block or spread over in scattered fragments. The entire area might be in a single territorial jurisdiction or might spread over to more than one such jurisdiction. The common factor was that it was under single management having its own set of facilities and resources.

The holder or the operator as far as the agricultural census is concerned is the person who was responsible for the management of the holding. He had to take decisions on all major agriculture operations. It was the extent of responsibility of decision taking that accounts. He might do the work of one or more operations himself and may direct and supervise the work done by others under his instructions. The operator might thus be an owner, a member of owner's household, tenant, share cropper, etc. The operational holder might be individual or joint or institutional. If the holding was operated either by one person alone or by a group of persons who are the members of the same household, it was considered as an individual holding. If two or more persons belonging to two different households shared jointly the economic and technical responsibility for the operation, it was treated as joint operational holding. Holdings such as government farms,

sugarcane factories, co-operative farms, land managed by trust etc. were treated as institutional holdings. Operated area included both cultivated and uncultivated area provided part of it is put to agricultural production during the reference period. It covered the land occupied by farm buildings including the house of the holder provided such buildings are within the cultivated area. Operated area would exclude government forest land, government waste land etc.

During the previous censuses, the data in respect of main census was collected utilising the services of the Revenue personnel under the technical guidance of this department. During the present census, the data on main census were collected utilising the services of investigators of this department, in addition to their normal duties under the close supervision of taluk and district level officers.

The details regarding the number and area of operational holdings were tabulated in respect of all the fourteen size classes ranging from less than 0.05 hectare to 50 hectares and above for individual, joint and institutional holdings. Similar tables for scheduled caste and scheduled tribes were also prepared.

3. Results of the survey

The total number of operational holdings in the state have increased from 41.81 lakhs in 1980-81 to 48.87 lakhs in 1986-87 recording an increase of 18.9%. The area comprised in those holdings during the respective years were 18.05 lakh hectares and 17.53 lakh hectares respectively. The average size of the holding has decreased from 0.43 hectare to 0.36 hectare during the above period.

The number of holdings have increased in all the districts except Kozhikode. The area has declined in Idukki, Ernakulam, Malappuram and Kozhikode districts. This may be due to the under reporting by the informants. The number of holdings belonging to scheduled caste has increased from 3.57 lakhs to 4.87 lakhs and scheduled tribe from 0.41 lakhs to 0.50 lakhs.

The details regarding joint holdings ie. holdings operated by two or more persons belonging to different households and share jointly as partners the economic and technical responsibility for the operation of the holding was also collected. During the current census, it is estimated that 7421 holdings are operated jointly.

The number of institutional holdings has been estimated as 45553 and these holdings have accounted for an area of 1.10 lakh hectares.

Provisional number and area of operational holdings in the state under different size classes for scheduled castes, scheduled tribes, others and total are given in appendix. Number and area of operational holdings for scheduled caste, scheduled tribe and others and total in different districts are also given in appendix. Fourteen size classes have been originally adopted for classifying the holdings according to the size and detailed district-wise tables in respect of the estimated number and area of operational holdings have been prepared separately for scheduled caste/scheduled tribe and others. But for discussion and comparison of results, these fourteen size classes have been regrouped into five size classes viz. (1) below 1 hectare (marginal) (2) 1 - 2 hectares (small), (3) 2 to 4 hectares (semi-medium) (4) 4 to 10 hectares (medium) (5) 10 hectares and above (large). For the purpose of

comparison the particulars of the number of holdings and area in respect of the operational holdings in Kerala are given below:-

The number of holdings (including institutional) below 1 hectare was 37.28 lakhs during 1980-81 where as it increased to 44.73 lakhs in 1986-87. The percentage of marginal holders having less than one hectare has increased from 89.2 to 91.5 and they operate 46% of the total area. In the case of holders belonging to scheduled caste a marginal increase in the percentage has been noted while marginal holders belonging to scheduled tribes declined. Large holdings above 10 hectare in size was 0.1% in 1980-81 and 1986-87. The holders belonging to this group operated an area of 9.64% of the total area.

Considering the increasing demand for data to block level, the number and area of individual holdings in 6 size classes viz. 0.02 hectare 0.02 - 0.5 hectare, 0.5 hectare to 1 hectare, 1 - 2 hectares, 2 - 4 hectares and 4 hectares and above have been prepared for each block. The details for the municipalities and corporations in a district have been combined together and incorporated in the tables of the concerned district. The above tables have been given in appendix. It is hoped that it will be useful to the planners and administrators.

A scrutiny of the block-wise details show that the number of holdings varied between 9391 in Palluruthy block with an area of 955 hectares in Ernakulam district and 56659 in Payyannur block within an area of Cannanore district 31632 hectares. There were four blocks having more than 50000

holdings viz. 50868 in Sultan Battery block in Wayanad district 51965 in Kunnamangalam block in Kozhikode district 55587 in Taliparamba block in Cannanore district and 56659 in Payyannur block in Cannanore district. At the same time there were three blocks having number of operational holdings less than 12000. They were Palluruthy (9391) and Vytila (11196) in Ernakulam district and Attapadi (11405) in Palghat district.

The total area of the operational holdings was maximum in Sultan battery block 37055 hectares followed by Irirkur block 33229 hectares in Cannanore district. Minimum operated area was reported by Kodungalloor block in Trichur district viz. 2033 hectares.

The average area of the operational holdings was minimum in Anchalum moodu block in Quilon district and maximum in Attappadi block in Palghat district.

The maximum number of holdings were in the size class 0.02-0.5 hectare and minimum in the size class 4 hectares and above in almost all blocks.
